Extension of time under s 15AC

Dear Weather User

On 8 May 2023, the Bureau of Meteorology (Bureau) advised the Office of the Australian Information Commissioner (OAIC) that it had not made a decision on your FOI request of 7 April 2023 within the statutory period provided by the *Freedom of Information Act 1982* (Cth) (the FOI Act). Consequently, the FOI Act deems that the Bureau has refused your request.

However, s 15AC of the FOI Act allows the Information Commissioner to extend the processing time for an FOI request where the initial decision period has ended and the agency or Minister has not provided the applicant with notice of a decision. The Bureau has applied for further time to finalise your request, to 22 May 2023.

The Bureau attempted to obtain an agreement under s 15AA of the FOI Act for an extension of time from you. The Bureau advised that you refused the request for a 30-day extension.

Decision

As a delegate of the Information Commissioner, I am authorised to make decisions on applications for extensions of time under s 15AC(5) of the FOI Act.

I have decided to grant the Bureau further time to **22 May 2023** to process your request. My reasons and considerations follow:

- The Bureau advised on 8 May 2023 that 'we have completed the document searches and reviewed the documents; the FOI decision-maker now needs to finalise the decision. We estimate completion in the coming week...'.
- The application is for a 14-day extension of time, which is not excessive in this instance.
- Granting this extension of time is expected to provide you with a substantive decision by the Bureau on your request by 22 May 2023, which will be substantially sooner than a decision by Information Commissioner review (IC review). It is expected to reinstate your right to seek an internal review of a substantive decision

by the Bureau and to extend the timeframe for you to apply for an IC review of the Bureau's anticipated decision.

Based on the information currently before the OAIC, I am satisfied that an extension until **22 May 2023** is appropriate in this instance, and I consider the additional days represent a reasonable amount of time in the circumstances.

This extension of time under s 15AC of the FOI Act means that the deemed refusal is taken never to have applied if the Bureau makes a decision on your request by 22 May 2023. Such an extension can only be granted once and cannot be extended by a variation.

I note that the *Freedom of Information (Charges) Regulations 2019* provides if an applicant is not notified of a decision on a request within the statutory time limit (including any extension of time), the agency or minister cannot impose a charge for providing access, even if the applicant was earlier notified that a charge was payable (regs 7(2), (3)). This extension under s 15AC of the FOI Act does not mean that charges can be reimposed and any deposit you have paid should be refunded.

If you do not receive a decision by 22 May 2023, or you disagree with the Bureau's decision, you may wish to seek IC review <u>here</u>. Further information on <u>applying for IC review</u> is available on the OAIC <u>website</u>. An application for IC review would need to be made within 60 days of the Bureau's decision or deemed decision.

Review rights

If you disagree with the Office of the Australian Information Commissioner's (OAIC) decision you can apply to the Federal Court of Australia or the Federal Circuit Court for a review of a decision of the Information Commissioner if you think that a decision by the Information Commissioner to grant an extension of time is not legally correct. You can make this application under the *Administrative Decisions (Judicial Review) Act 1977*.

The Court will not review the merits of your case but it may refer the matter back to the Information Commissioner for further consideration if it finds the decision was wrong in law or the Information Commissioner's powers were not exercised properly.

An application for review must be made to the Court within 28 days of the OAIC sending the decision to you. You may wish to seek legal advice as the process can involve fees and costs. The OAIC has the power to investigate complaints about an agency's actions under the Freedom of Information Act 1982 (FOI Act). This is a separate process from asking for an Information Commissioner review following a decision made under the FOI Act. Complaints usually focus on how an agency has handled your FOI request or complied with other obligations under the FOI Act, rather than the decision itself.

In some cases, the Information Commissioner's investigation of a complaint may lead to the agency addressing the issues that you have complained about. In other cases, the Information Commissioner may make suggestions or recommendations that the agency should implement. The Information Commissioner can only make non-binding recommendations as a result of a complaint. You and the agency will be notified of the outcome of the investigation.

FOI complaints to the OAIC must be made in writing. Our preference is for you to use the **online FOI complaint form** if at all possible.
