It is damaging to our young people, it racially profiles without facts and is consistently derogatory to Aboriginal children within our town. Members of this group have encouraged others to get shot guns and shoot children. Some members have wished harm on children. This forum has a massive audience of up to 12000 people.

I am shocked that this forum is able to exist. I fear that an incident similar to that of Cassius will happen in our town because of the group consensus and encouragement of its members to take matters into their own hands. s47F

Teenagers read these posts in our community. I can't imagine how it would make them feel. s47F

I am sickened by the racist hate that this forum breeds. Something has to give and I believe it starts with deactivating this forum and other forums like it. I can't believe that in this day and age in Australia people are able to speak like this about our most vulnerable. It flies in the face of the uluru statement and the government's commitment to action. Its spreading incorrect information about incarceration of aboriginal youth and encouraging harsher penalties which we know does not work. Any attempt of Education or calling out members for being racist ends in people being attacked as do gooders. Please help our town and our people.
