### **Request for access under the *Freedom of Information Act 1982* (Cth)**

I refer to your email of 7 May 2015 in which you request access, under the *Freedom of Information Act 1982* (the FOI Act), to the following:

*'all information available on the finances and any complaints filed against Indonesian furniture exporter businesses CV Rakabbu and CV Roda Jati.'*

### **Timeframe for processing your request**

Providing that the documents sought can be reasonably identified, the statutory timeframe for processing your request will commence the date your request was received by the ACCC, being 7 May 2015. This timeframe may be extended by the ACCC where:

- (a) Charges are levied as prescribed by the *Freedom of Information (Fees and Charges) Regulations 1982* (the FOI Regulations) (see Charges below); and/or
- (b) Consultation with third parties is necessary (see Consultation with third parties below).

### **Charges**

If the ACCC decides that you are liable to pay charges in respect of your request, the ACCC will prepare and send you a cost estimate outlining the likely cost of processing the request. The statutory timeframe is placed on hold from when this is sent to you.

You will normally be required to either pay a 25% deposit of the estimated charges, or make an application for the waiver of the fees in accordance with the FOI Act.

Once the deposit has been paid (or an agreement reached on a waiver application) the statutory timeframe resumes.

You will be notified of any charges in relation to your request or of a decision as soon as practicable.

### **Consultation with third parties**

The ACCC may be required to consult with other parties (third parties) where information relating to third parties arises in documents sought by your request. The FOI Act prescribes a further 30 days processing time for the ACCC to undertake this consultation. You will be advised as soon as possible of any requirement to consult with a third party.

### **Decision**

An authorised decision maker will then assess the documents to decide if they can be released, or should be exempt from release. You will be notified of a formal decision and your review rights.

Any documents to which access has been granted will be released after the remainder of the assessed charge has been paid. Please note that these charges must be paid even if you no longer require the documents or if no documents are granted.

### **Publication of documents released under FOI**

In accordance with section 11C of the current FOI Act, please be aware that any information released to you in response to your FOI request may be published on the ACCC's website ([foi.accc.gov.au](http://foi.accc.gov.au)). Information relating to your identity or the personal, business, commercial, financial or professional affairs of yourself and others will not be published **if it would be unreasonable to do so**. The ACCC will not publish any exempt information.
