NOTICE OF DECISION

Decision

REASONS FOR DECISION

Material taken into account

In making my decision, I had regard to the following:

- the terms of your request;
- the content of the documents to which you sought access;
- advice from departmental officers with responsibility for matters relating to the documents to which you sought access;
- the relevant provisions of the FOI Act;
- the Department's guidance material on the FOI Act; and
- the Guidelines issued by the Australian Information Commissioner under s93A of the FOI Act.

Findings of facts and reasons for decision

Where the schedule of documents indicates an exemption claim has been applied to a document or part of document, my findings of fact and reasons for deciding that the exemption provision applies to that document or part of document are set out below:

Section 47F - Personal Privacy

Section 47F of the FOI Act conditionally exempts a document if its disclosure would involve the unreasonable disclosure of personal information about any person.

Appendix B of Document 1 contains name of individuals and information about their position in their respective organisation which can be used to identify the individual. This is personal information for the purposes of section 47F.

Subsection 47F(2) of the FOI Act lists a number of matters which I must have regard to in deciding whether disclosure of this information would amount to an unreasonable disclosure of personal information. Taking into account these factors, I have formed the view that disclosure of this information would be unreasonable because:

- the personal information is not well known;
- the individuals to whom the above information relates may not be well known to be associated with the matters dealt with in the requested information; and
- it is unlikely that some of the above information could be obtained from publically accessible sources.

On this basis, I am satisfied that the names and position details of these individuals are conditionally exempt under section 47F.

Section 47F is a conditional exemption and as such I have considered whether disclosure would on balance be contrary to the public interest. In this regard, I have considered the public interest exemption factors set out in section 11B(3) of the FOI Act. I am satisfied that there would be no benefit to the public in disclosing the names and position details of the

individuals listed in Appendix B of Document 1. There is, however, a public interest in protecting the privacy of those individuals by not disclosing this information.

Taking these matters into account I find that it would, on balance, be contrary to the public interest to release the personal information. The personal information is therefore exempt under section 47F of the FOI Act.
