

# Appendix A Detailed Methodology



### A.1 Phase 1 - Inception and project planning

An inception meeting was held with DoHA on 1st February 2010. The aims of this meeting included obtaining a briefing about NCPIC and its establishment from DoHA, identifying key documents and issues, and confirming the methodology and timeframes for the evaluation.

An initial telephone discussion was conducted with the NCPIC Director, Professor Jan Copeland, on 8th February. The aims of this discussion included identifying key documents and data to be provided for the evaluation, identifying key issues to consider, and discussing NCPIC's role in the evaluation and key points for input into this process.

A preliminary program logic (and hierarchy of outcomes) was developed and set out in the Urbis tender. This original version was modified at numerous points throughout the course of the evaluation in light of issues raised in the consultations, the review of key documents, and input provided by DoHA and the NCPIC Director.

### A.2 Phase 2 – Background research

#### A.2.1 Review of key documents

Key documents provided by DoHA and the NCPIC were reviewed. The review of documents informed an understanding of:

- the aims, objectives and activities of the NCPIC as originally intended
- the governance and staffing roles and arrangements
- the planning process for NCPIC and the rationale underpinning the development of specific NCPIC activities and materials
- the appropriateness of the activities undertaken for achieving the identified needs and aims of NCPIC
- the spread and balance of activities and resources across the outcome areas
- the appropriateness of the activities undertaken for contributing towards the priority areas of the National Cannabis Strategy (NCS)
- the efficiency of activity implementation and any challenges or issues experienced.

Documents reviewed included: *The National Cannabis Strategy 2006-2011*, *The National Drug Strategy 2004-2009*, *The NCPIC Strategic Plan 2007-2010*, *NCPIC Annual Work Plans*, *The NCPIC Communications Strategy 2008-2010*, the *NCPIC Application for Funding*, the *Standard Funding Agreement between the Commonwealth of Australia and the University of New South Wales National Drug and Alcohol Research Centre (NDARC)*, *The Cannabis Resource Audit (Alcohol and Other Drugs Council of Australia 2008)*, and information relating to budget and financial resource allocations.

At the commencement of the evaluation, NCPIC provided Urbis with a substantial submission including 61 appendices. This has also been reviewed.

#### A.2.2 Data review

The submission provided by NCPIC (and accompanying appendices) contained data and evaluative material. This included data relating to website activity and a website user satisfaction survey, data relating to Helpline activity and a Helpline process evaluation conducted by NCPIC, evaluative materials

relating to the workforce training conducted by NCPIC and evaluative materials relating to the National Cannabis Conference (based on feedback forms from attendees).

Where possible, this data has been used to inform an understanding of the impacts and reach of NCPIC's activities (ie across the States and Territories and urban/regional localities), the extent to which the varying target audiences are engaged with NCPIC activities, and user satisfaction.

### A.2.3 Quality assessment of information

A quality assessment of a sample of NCPIC materials and publications was conducted. The quality assessment was undertaken to complement the qualitative research findings and to inform an analysis of NCPIC's success in meeting its objective of providing the community with high quality, evidence based information. An approach for selecting materials was developed to ensure that various publication types and formats, publications covering a range of topics, and publications targeted at different stakeholders were considered. The approach involved, in most instances, the selection of the most recent edition of publications. For materials that are not dated resources were selected at random. Input provided by by NCPIC and DoHA into the selection of materials was also taken into account.

A brief scan of relevant literature was undertaken to identify and establish a criteria against which to assess the quality of the materials.

The Quality Assessment Criteria please is provided at Appendix C.

#### A.2.4 Literature scan

A brief scan of current literature was undertaken to provide an evidence base to inform the qualitative evaluation findings. Literature was sought in relation to the following topics: patterns of cannabis use in Australia, community attitudes towards cannabis use, problems associated with cannabis use, and cannabis treatment and prevention. An initial list of key documents relating to these topics was complied by Urbis and sent to NCPIC to ensure that seminal pieces of research were not overlooked. Documents provided by NCPIC were included in the literature scan.

## A.3 Phase 3 – Fieldwork consultations

### A.3.1 Consultations with consortium members

Two Urbis team members attended a meeting of the NCPIC Advisory Group (which included the seven consortium members) on 18th February at NDARC. Urbis conducted a one hour workshop with the Group as part of that meeting. Advisory Committee members were subsequently provided with the opportunity to participate in one-on-one follow-up telephone interviews, and a number chose to do so.

An additional interview was also conducted with a key informant from the University of NSW.

The complete consultation list is provided at Appendix B.

### A.3.2 Workshop with NCPIC staff members

An on-site workshop was undertaken with NCPIC staff on 1<sup>st</sup> March. A face-to-face interview was also undertaken with a key staff member unable to attend the workshop.

The staff members consulted are included in the consultation list provided at Appendix B.

#### A.3.3 Key stakeholder interviews

Interviews were conducted with key stakeholders from a selection of national and State/Territory based Australian organisations including peak bodies, service providers and government agencies. Organisations from a variety of sectors were consulted including drug and alcohol, health, education, youth, legal/criminal justice, evaluation/research, Indigenous and Non-English Speaking Background (NESB). The list of stakeholders to interview was developed taking into account:



- suggestions made by NCPIC, DoHA and in Urbis' tender for the evaluation
- the need to include stakeholders working across all States and Territories (and at at State/Territory and national level), as well as a wide range of sectors relevant to the various NCPIC activities.

37 individuals participated in interviews. The interviews were undertaken in a number of formats: one-on-one telephone interviews, teleconferences, face-to-face interviews and emailed responses.

The list of all stakeholders consulted is provided at Appendix B

#### A.3.4 Interviews with NCPIC clients

A total 21 telephone interviews with clients of the NCPIC Information and Helpline were conducted. Clients were recruited through their contact with the Helpline. At the request of Urbis, over the period 1st-30th March 2010 Helpline staff asked all Helpline callers if they were willing to participate in the evaluation, and if so, their contact details were passed onto Urbis.

The interviews were an average of 10-15 minutes in length.

Participants represented a relatively even gender spread with 52% being female and 48% male. The average age of participants was 46 years old. The youngest participant was 23 years of age and the oldest participant was 69 years of age. Participants were most commonly from New South Wales (52%), followed by Victoria (24%), Queensland (19%), and Western Australia (5%).

A pop-up button advertising the evaluation was also placed on the NCPIC website, but no clients were recruited through this process.

#### A.3.5 Focus groups with young people

Two focus groups with independently recruited young people were conducted. The key aim of these groups was to inform an understanding of the effectiveness and appropriateness of NCPIC activities and materials for engaging with their target audience, particularly young people. Focus group participants were shown examples of NCPIC materials and resources aimed at young people to encourage a discussion regarding: the appeal, the perceived relevance of information, the presentation and format, the types of messages and approaches, the dissemination methods and the potential impacts on young people's cannabis related attitudes and behaviours.

In total, 21 young people participated in the groups. The first group was young people aged 14-18 years and comprised 10 participants, five female and five male. In addition to exploring the general NCPIC materials for young people, this group tested a sample of NCPIC's preventative materials. It was not specifically required that the participants be cannabis users (although a minority were in practice).

The second group included young people aged 20-29 years and comprised 11 participants, nine male and two female. In addition to exploring the general NCPIC materials for young people, this group tested a sample of NCPIC's intervention materials. Participants in this group were all cannabis users.

## A.4 Phase 4 – Analysis and reporting

This Report is being submitted to DoHA, the Director of NCPIC and the NCPIC consortium members. The consortium members will provide feedback on the Report to the Director of NCPIC. DoHA and NCPIC will each be submitting one set of consolidated feedback to Urbis by 3rd May. A teleconference with consortium members is also scheduled to be held on 3rd May. The teleconference will focus on key issues members wish to discuss separately to the feedback provided to the NCPIC Director and overall high level key issues concerning the evaluation findings.

The Final Report will be submitted by Urbis on 10th May.

Would this postcard prompt you to call the Helpline number or visit the website? Why/why not? Does this postcard make you think differently about cannabis?

5. Real Stories about Using Cannabis – Get participants to look at the postcards. Can you tell me what you think these postcards are about? If you came across these postcards at your school (i.e. displayed in the classroom) would you be included to pick them up and read them (prompt- are the graphics eye-catching? Is it clear what the postcards are about?) Would these postcards prompt you to visit the NCPIC website for further information? Why/Why not?

Ask participants to look at the young people's section of the website and the Real Stories. What did you think of this webpage? Was the webpage easy to navigate? Was the information provided relevant to people your age? Did it tell you things about cannabis you are interested in knowing? Did it provide you with new information? What did you think about the design, graphics and presentation of the webpage? What did you think of the language used? Does the website make you think differently about cannabis? Would it discourage you from using cannabis? Anything else you would like to comment on?

- 6. **Factsheets** (Ask participants to look at a list of the factsheet topics) Do you think any of these topics are relevant to you or other people your age? Which ones are most relevant (choose top three). Let's look at one factsheet in more detail. What do you think about this factsheet? Does the factsheet provide you with relevant information? New information? What do you think about the presentation? Is it easy to use? It is engaging and interesting? What about the language? Does the factsheet make you think differently about cannabis? Would it discourage you from using cannabis? Anything else you would like to comment on?
- 7. Of all the materials we have looked at, which one do you think is the most effective for engaging with people your age? Why? Which one do you think is the least effective? Why? Which one is most likely to make you think differently about cannabis or would be most likely to discourage you from using cannabis? Why?
- 8. Thinking about the topics that are covered in the resources are there other things about cannabis that you would be interested in knowing?
- 9. Do you have suggestions for how NCPIC materials could be improved? Can you think of any other types of materials that would be effective for engaging with people your age?

### **NCPIC** activities

Some of NCPICs current/future activities include poster competitions where school students are invited to design posters to promote the Centre (we looked at two of the winning entries earlier), short film competitions, an online chat room where young

people can ask the staff questions relating to cannabis, developing interactive classroom activities for teachers to do with their students.
