**RE: YOUR FREEDOM OF INFORMATION REQUEST [FOI202324/12]**

I refer to your request received by the ABS on 18 October 2023 in which you seek:

*"A list of urban areas/localities in Australia by state? I have been looking for a while but can't find a concrete list. Preferably this would include population figures from the 2021 census and geographical coordinates, but it's completely fine if that's impossible."*

**Response to Your Request**

I am an authorised decision maker under section 23 of the *Freedom of Information Act 1982* (FOI Act). I have reviewed your request and determined that much of the information you are seeking, if held by the ABS, would have been collected under the authority of the *Census and Statistics Act 1905* (C&S Act). Information collected under the C&S Act is exempt from the FOI Act under Schedule 2, Part II, Division 2. Therefore, I am refusing access to any such documents we may hold on the basis that they are exempt.

**Alternative access arrangements**

In our correspondence to you on 24 October 2023, the ABS provided you with two spreadsheets outside of the FOI Act that provide some of the information you are seeking. These spreadsheets contain information from the most recent Census, including the full data of population estimates and components by Local Government Area (LGA) and Statistical Area Level 2 (SA2).



## **INFORMATION ON RIGHTS OF REVIEW**

### **1. INTERNAL REVIEW OF DECISION**

If you disagree with our decision you have the right to apply for an internal review under section 54 of the FOI Act.

Application for a review of the decision must be made within 30 days of receipt of this letter. No particular form is required but it would assist the decision-maker if you set out in the application the grounds on which you consider that the decision should be reviewed.

### **2. AUSTRALIAN INFORMATION COMMISSIONER REVIEW OF DECISION**

Section 54L of the Act gives you the right to seek a review of the decision from the Information Commissioner. An application for review must be made within 60 days of receiving the decision.

### **3. COMPLAINTS TO THE INFORMATION COMMISSIONER**

Section 70 of the Act provides that a person may complain to the Information Commissioner about action taken by an agency in the exercise of powers or the performance of functions under the Act.

A complaint to the Information Commissioner must be in writing and identify the agency the complaint is about. It should be e-mailed to [foidr@oaic.gov.au](mailto:foidr@oaic.gov.au) or posted to:

The Information Commissioner may decline to investigate the complaint in a number of circumstances, including that you did not exercise your right to ask the agency, the Information Commissioner, a court or tribunal to review the decision.
