#### NOTICE OF DECISION

I refer to your request to the Department of Health (Department) of 5 June 2015 seeking access under the *Freedom of Information Act 1982* (FOI Act) to:

'all documents including correspondence, briefings file notes and telephone records of communications relating to the meeting (including planning and follow up) held on June 4 2013 between Mr Richard Eccles and the AFL including Mr Gillon McLachlan and Mr David Evans, then President of the Essendon Football Club.'

I am writing to advise you of my decision.

### Decision

All reasonable steps have been taken to find any documents relevant to your request including a thorough and extensive search and consultation with the relevant policy and program areas.

I am satisfied that the documents referred to in your request do not exist.

As a consequence, I refuse access to the documents referred to in your request pursuant to section 24A of the FOI Act.

### **Review rights**

If you are dissatisfied with my decision, you may apply for an internal review or Australian Information Commissioner (Information Commissioner) review of the decision.

### Internal review

Under section 54 of the FOI Act, you may apply in writing to the Department for an internal review of my decision. The internal review application must be made within 30 days of the

date of this notice (or such further period as the Department allows). Where possible please provide reasons why you consider review of the decision is necessary.
