3.D.1.B.1. REPORT DIRECTLY TO COMAST;

3.D.1.B.2. EXERCISE OPERATIONAL CONTROL, THROUGH DEPLOYED COMPONENT COMMANDERS, OF ALL ADF FORCE ELEMENTS DEPLOYED TO THE MEAO; AND

- 3.D.1.B.3. EXERCISE NATIONAL COMMAND OF ALL ADF FORCE ELEMENTS DEPLOYED TO THE MEAO.
- 3.D.1.C. CDF WILL RETAIN A DIRECT AND IMMEDIATE RELATIONSHIP WITH COMDJTF-MEAO ON ISSUES OF STRATEGIC AND NATIONAL IMPORTANCE.
- 3.D.1.D. ADF COMBAT FORCE ELEMENTS DEPLOYED ON OP CATALYST MAY BE ASSIGNED WHERE APPROPRIATE, AFTER CDF APPROVAL, UNDER THE OPERATIONAL CONTROL OF AGREED US CENTRAL COMMAND COMPONENT COMMANDERS.
- 3.D.1.E. SITUATIONAL AWARENESS AND OPERATIONAL REPORTING WILL BE FUSED THROUGH COMDJTF-MEAO, WHO WILL BE THE PRIMARY SOURCE OF OPERATIONAL REPORTING FROM THE MEAO TO AUSTRALIA.
