NOTICE OF DECISION

I refer to your request of 10 June 2015 to the Department of Health (Department) seeking access under the *Freedom of Information Act 1982* (FOI Act) to:

"Correspondence between Ministers about the effects Sydney lockout laws will/or have had since their introduction in 2013, specifically in relation to increased drug or alcohol use in suburbs outside the lockout area"."

I am writing to advise you of my decision.

Decision
