Freedom of Information (FOI) request - Access Decision

On 12 April 2024, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

Can I please get the list of registered companies that can sponsor Business Analyst ANZSCO 261111?

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the documents relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access

4 Documents in scope of request

The Employer Sponsored Program Management Section within the Department has undertaken reasonable searches for documents within the scope of your request. They have advised that they have not been able to identify any documents within the scope of your request as no relevant document exists.

However, they have provided a response to your request as follows:

Having regard to your request and the types of documents that may fall within the scope of your request I am satisfied that the searches conducted were extremely thorough and all reasonable steps have been taken to locate any document relevant to your request.

5 Decision

Section 24A of the FOI Act provides that the Department may refuse a request for access to a document if all reasonable steps have been taken to find the document and the Department is satisfied that the document does not exist.

I am satisfied that the Department has undertaken reasonable searches in relation to your request and that no documents were in the possession of the Department on 12 April 2024 when your FOI request was received. As such, I am refusing your request based on the application of section 24A of the FOI Act.

7 Your Review Rights

Internal review

The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
