NOTICE OF DECISION ON FREEDOM OF INFORMATION REQUEST

I refer to your correspondence, dated 18 September 2015, in which you requested access, under the *Freedom of Information Act 1982* (FOI Act), to:

“The document known as QB15-000025 dated 11 February 2015.”

Background

The purpose of this letter is to provide you with the decision relating to the document that is the subject of your request.

FOI decision maker

I am an authorised officer pursuant to section 23 of the FOI Act to make a decision on this FOI request.

Identified document & decision

I identified the requested document and have decided to release it intact. A copy of the identified document is at Enclosure 1.

Material taken into account

In making my decision, I had regard to:

- a. the terms of your request;
- b. the content of the identified document in issue;
- c. relevant provisions in the FOI Act;
- d. the *Guidelines published by the Office of the Australian Information Commissioner under section 93A of the FOI Act* (the Guidelines); and
- e. advice and clarifying information provided by an officer in Capability Acquisition and Sustainment Group (CASG).

Contextual statements

CASG noted that release of the identified document without some additional context may lead to confusion, and asked that I provide the following information in regards to the MH-60R:

- *The 2009 Defence White Paper stated that as a 'matter of urgency' the Government will acquire a fleet of at least 24 new naval combat helicopters to provide eight or more aircraft concurrently embarked on ships at sea. The urgency for acquiring new naval combat helicopters was driven by two main factors: the need for a credible Anti-Submarine Warfare and Anti-Surface Warfare helicopter capability, and the increasing obsolescence difficulties with maintaining the current S-70B-2 Seahawk 'Classic' fleet. This capability would replace the 16 S-70B-2 Seahawk 'Classic' helicopters then in-service and the 11 cancelled Seasprite helicopters, which were cancelled 8 March 2008.*
- *On 24 February 2010, Government announced First Pass approval for Project AIR 9000 Phase 8, the Future Naval Aviation Combat System. It was announced that a cost capped competition would be conducted to consider the MH-60R Seahawk 'Romeo' , sourced from the US Navy (USN) via the US Foreign Military Sales (FMS) program, and the NATO Frigate Helicopter (NFH), sourced via a direct commercial sale from Australian Aerospace.*
- *A Request for Tender was issued to Australian Aerospace (now Airbus Group Australia Pacific) in April 2010 for the NFH (based on the French Navy variant). A Letter of Request was released to the US Navy on the same day for the MH-60R.*
- *Both parties responded by the due date in July 2010 and then responded, at Defence's request, with revised and final offers in February 2011. A detailed evaluation of the responses was then completed, with the decision by Government on 16 June 2011 to acquire 24 MH-60R Seahawk 'Romeos'.*
- *A total of 14 MH-60R Seahawk 'Romeos' have been delivered to date (as at 24 Sep 15)*
- *The project remains ahead of schedule.*

The following relates to content relating to C-27J:

- *At the time of execution, the C-27J process was not conceived as a competitive evaluation and its use as an exemplar after the fact risks giving undue support to the concept*
- *USG policy prevented an FMS offer being provided in direct competition to a US supplier direct commercial sales (DCS) offer.*
- *The C-27J FMS evaluation was conducted against older DCS tender data on record, supplemented with up-dated OEM/partner information where available, and at no point did this DCS consideration involve a US supplier.*
- *The USAF JCA variant C-27J was only available via FMS at the time, the commercial alternatives considered were for subtly different version with less capability*
- *The option to procure C-27J via FMS was extremely time constrained due to the limited duration of the USG production contract.*

The following relates to content referring to Option 3 and Option 4 in the Background section of the document:

- *At the time of the Senate Economics Reference Committee hearing on 30 September 2014, Future Submarine Program resources had been focused on the 'evolved Collins' option (Option 3) and new design option (Option 4).*
- *This work had been completed before Government's announcement of the Competitive Evaluation Process.*
- *It remains the case that no decision has been made on submarine cooperation with any country.*
