FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION (NIL RESPONSE)

This notice contains my decision in relation to access to documents in the possession of the National Offshore Petroleum Safety and Environmental Management Authority (NOPSEMA) that were requested under the *Freedom of Information Act 1982* (the FOI Act).

You requested access to 'emails and documents in relation to the delegation or discussion of any delegation of any powers or functions of NOPSEMA to any person or organisation external to NOPSEMA in the past 12 months.'

I am the decision maker in this matter, having been authorised under s 23 of the FOI Act.

Decision

I identified zero (0) document[s] which fall within the scope of the request. After running my own search through NOPSEMA's internal document repository system, and in consultation with our Communications team, I had our Information Technology team also perform a thorough search of the system for any documents within the scope.

After reviewing the results of the searches, I can confirm that no documents exist that are within the scope of your request.

Charges Waived

I note that you asked that the charges for your request be waived in the public interest. As this request was able to be processed promptly, with minimal resource expenditure, I have chosen to exercise my discretion and not impose any charge.

Your review rights

If you are dissatisfied with my decision, you may apply for internal review or Information Commissioner Review. We encourage you to seek internal review as a first step as it may provide a more rapid resolution of your concerns.



Internal review

Any application for an internal review of the decision must be made in writing within 30 days of receipt of this decision. No fee is required for an application for internal review. A request for internal review should be directed to the following address:
