Your Freedom of Information Request of 30 October 2015

I refer to your email of 30 October 2015 seeking access under the Freedom of Information Act 1982 (FOI Act) to:



APPENDIX 1 – REVIEW RIGHTS

If you are dissatisfied with this decision, you have certain rights of review available to you. Firstly, under section 54 of the FOI Act, you may apply for an internal review of the decision.

Your application must be made by whichever date is the later between:

- 30 days of you receiving this notice; or
- 15 days of you receiving the documents to which you have been granted access.

An internal review will be conducted by a different officer from the original decision-maker.

No particular form is required to apply for review although it will assist your case to set out in the application the grounds on which you believe that the original decision should be overturned. An application for a review of the decision should be addressed to:

Review by the Australian Information Commissioner

Alternatively, under section 54L of the FOI Act, you may seek review of this decision by the Information Commissioner without first going to internal review. Your application must be made within 60 days of you receiving this notice.
