Re: Freedom of Information (FOI) Request

I refer to your revised request under the Freedom of Information Act 1982 (FOI Act) to:

"a copy of the following documents and records involving the Trans-Pacific Partnership (TPP) Ministerial meeting in Atlanta, Georgia, USA from 30 September 2015 to 1 October 2015 be provided to me: programs, talk slides, and budgets. I request *only* documents related to the TPP meeting that have the keywords "intellectual property".

I am authorised under section 23 of the FOI Act to make decisions, and have been appointed to be the decision-maker on your request in line with Departmental procedures.

This notice is to advise you that searches undertaken by the Department's Goods and Investment Branch, Office of Trade Negotiations has failed to identify any documents relevant to the scope of your request. Please note, our searches also included *documents* related to the meeting with the keywords "company" or "corporation" on the basis that you had requested that we do so.

I am therefore satisfied that the documents sought are either:

- (i) within the Department's possession but cannot be found; or
- (ii) do not exist, and

therefore in accordance with the provisions of section 24A(1)(b)(ii) of the FOI Act, your request for access is refused.

Please find your rights of review outlined below.

Internal review
