Dear Mr Degan,

Valid application for access to government information

We received your access application under the Government Information (Public Access) Act 2009 (GIPA Act) on 19 February 2016:

I'd like to know how much we spent on the development of the new My Marrickville smart phone applications. So I'd like to make an informal access application for all invoices since 1 January 2015 from the application developer, which appears to be Acresta Mobile.

If there's a better way to request this information or if it would assist if I changed the scope of my request, I'm happy to do so. If you're unable to process this request as an informal access application, please consider this a formal GIPA request.

It was made valid (by receipt of address and payment) on 4 March 2016. It is now a valid application and must be decided within 20 working days, that is, by 1 April 2016.

If your application has not been decided by that date, it is taken by the GIPA Act to have been refused. If this occurs, you are entitled to a refund of your application fee and you may seek a review of this refusal (see enclosed brochure).

Processing charges

There may be charges for processing your application. The application fee you have paid will count towards these charges. We will provide you with an estimate of any charges at the earliest opportunity and you will have the opportunity to seek a discount or waiver. We may ask that you pay an advanced deposit of up to 50 percent of these costs. You also have the right to seek a review of our decision about processing charges (see enclosed brochure).

Inclusion of details in disclosure log

If you are granted access, the government information you are seeking may be of interest to other members of the public. If this is the case, the GIPA Act requires us to record the following details about your access application in our 'disclosure log':
