Thank you for meeting with us today re: outstanding payment summaries. We are checking the codes – as we have noticed that one of the payment summaries for a former employee who received a VR has the incorrect ETP code (e.g. a “T” code instead of an “R” code for redundancy. The T code = payment to a deceased estate). This has tax implications – so we are looking at the payment summaries that s 47F has sent us this afternoon to confirm these are correct.

Hoping we can give the ‘ok’ to the National Mailing Centre to post the payment summaries posted first thing Monday.

Can you please advise when the payment summary information will be sent to the ATO – so we can respond to enquiries? 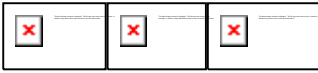
