Re: Freedom of Information (FOI) Request

I refer to your e-mail of 19 August in which you seek access under the provisions of the *Freedom of Information Act 1982* (FOI Act) to:

all documentation sent or received by the Australia-India Council which discusses the prospect of the sale of Australian uranium to India. My request includes (but is not limited to) the minutes of any meetings where this matter was discussed, arrangements and plans for relevant trade delegations, internal and external correspondence (including email) and reports.

I am authorised under section 23 of the FOI Act to make decisions, and have been appointed to be the decision-maker on your request in line with departmental procedures.

I advise that a search of files undertaken by the Australia-India Council has failed to identify any document relevant to the scope of your request.

The Australia-India Council's purpose is to broaden the relationship between Australia and India by encouraging and supporting contacts and increasing levels of knowledge and understanding between the peoples and institutions of the two countries. The Council initiates or supports a range of activities designed to promote a greater awareness of Australia in India and a greater awareness of India in Australia, including visits and exchanges between the two countries, development of institutional links, and support of studies in each country of the other. Its remit does not include the negotiation of bilateral agreements. I am therefore unable to meet your request in accordance with the provisions of section 24A(1)(b)(ii) as DFAT holds no documents relevant to your request.
