RE: Hornsby Shire Council Food Surveillance Activity Report 1 July 2014 to 30 June 2015

I refer to your letter dated 3 December 2015 regarding Hornsby Shire Council's food surveillance statistics for 1 July 2014 to 30 June 2015.

In your letter it indicates that only 79.6% of high and medium risk food premises within the Hornsby Shire Council received a food safety inspection. Since receiving your letter the Hornsby Shire Council Food Surveillance Activity Report has been reviewed. The review has indicated incorrect statistics were submitted to the NSW Food Authority in August 2015.

Details of the correct food surveillance statistics are as follows:

- Hornsby Shire Council has a total of 603 high and medium risk food premises.
- A total of 580 high and medium risk food premises were inspected.
- 23 food premises were not inspected

It was identified that 23 high/medium risk food premises were not inspected due to one of the following reasons:

- Council's electronic system did not identify all food premises that had not been inspected.
- Food premise inspections occurred just outside of the financial year
- A number of food premises submitted new food notification forms in the last week of the financial year and therefore Officers were not able to inspect them prior to the 30 June 2015.

As a result of reviewing Hornsby Shire Council's food surveillance statistics and identifying reasons why 23 food premises were not inspected, the following changes have been put in place to prevent incorrect results being generated again.

- Council's electronic system has been rectified to ensure all food premises that have not been inspected can be identified.
- A review of the food premises inspected and not inspected will occur 3 months prior to the end of the financial year to ensure inspections do not occur outside of the financial year.

Council will continue to receive food notification forms in the last week of the financial year and these will be prioritised however it is expected that some food premises will not be inspected due to time constraints.

However we are pleased to report that 96.1% of our high and medium risk food premises were inspected between 1 July 2014 and 30 June 2015.

I have attached additional information that will provide further evidence of the food surveillance statistics accumulated by Hornsby Shire Council.
