ACCESS TO INFORMATION REQUEST FOOD SAFETY INSPECTIONS - 2014, 2015 and 2016

I refer to your recent email of 15 November 2016 seeking access under the *Government Information (Public Access) Act 2009*, as an informal request, to the following:

- Number of food safety inspections carried out in your area annually, for the last three years?
- Number of warnings issued each year and how many fines each year?
- The percentage of all food outlets did the council inspect each year?
- The number of outlets shut down for non-compliance and if so what for and how many?
- The worst offences/biggest fines for each year?

As previously advised, under the *Government Information (Public Access) Act 2009*, Council may request this type of Application where the information sought is of a sensitive nature that requires careful weighing of the considerations in favour of and against disclosure.

Should you wish to continue with a Formal Application (application form attached), the \$30.00 application fee is payable prior to Council determining your Application.

Council will take no further action unless a Formal Application is lodged with the statutory fee of \$30.00.
