Additionally, an "emissary" of the "Crown Prince of Hutt Province" is currently in the Seychelles seeking high level meetings. We briefeds 33(a)(iii) on the Australian Government position by drawing on the helpful guidance provided in Administrative Circular P0044.

2. By way of background, s 33(a)(iii) advised us the initial contact was made following President Michel's successful re-election in July 2006. This was in the form of a congratulatory message from the "Crown Prince" of "Hutt River Province". The Seychelles authorities had responded in good faith to this message. In December 2006, s 33(a)(iii)

then received a follow-up communication informing the Seychelles Government that "Hutt River Province" was keen to establish diplomatic relations with the Seychelles and would like to appoint an Ambassador. An "Emissary" of Italian origin then appeared in the Seychelles last week seeking to firm up this relationship.s 33(a)(iii) noted to us that, in response to s 33(a)(iii) professed ignorance of the existence of the "Hutt River Province", the Emissary explained to the s 33(a)(iii) that the Hutt River Province was similar in structure to the Sovereign Order

of Malta, only it had a greater land mass. The "Emissary" also showeds 33(a)(iii) a copy of his passport and demonstrated that he had in fact entered the Seychelles on his "Hutt River" passport.

3.s 33(a)(iii) appreciated our guidance on this matter and advised us he would deal with the "Emissary" appropriately tomorrow, 12 January.

THE HUTT RIVER PROVINCE IS NOT RECOGNISED BY THE AUSTRALIAN GOVERNMENT - LEGALLY OR IN ANY OTHER WAY. DOCUMENTS PURPORTING TO BE "PASSPORTS" ISSUED BY THE "HUTT RIVER PROVINCE" ARE SIMILARLY NOT RECOGNISED AS VALID TRAVEL DOCUMENTS BY AUSTRALIA. CABLE PROVIDES BACKGROUND ON THE AUSTRALIAN GOVERNMENT'S POSITION ON THE "HUTT RIVER PROVINCE" AND THE OVERSEAS ACTIVITIES OF THOSE PURPORTING TO BE ITS REPRESENTATIVES.

REFTELS REPORTED THE SALE IN LEBANON OF "HUTT RIVER PROVINCE" 'PASSPORTS' AND 'CITIZENSHIP' DOCUMENTS BY A LEBANESE RESIDENT, MR  $47\ F(1)$  PURPORTING TO BE THE "HUTT RIVER PROVINCE CONSUL-GENERAL" IN BEIRUT (WE UNDERSTAND THAT FOLLOWING DISCUSSIONS WITH POST,  $8\ 47\ F(1)$  has since stopped doing so). Post sought advice ON AUSTRALIA'S POSITION REGARDING THE "HUTT RIVER PROVINCE" AND THE OVERSEAS ACTIVITIES OF THOSE PURPORTING TO BE ITS REPRESENTATIVES.

- 2. AS YOU ARE AWARE, THE AUSTRALIAN GOVERNMENT DOES NOT/NOT RECOGNISE THE "HUTT RIVER PROVINCE", EITHER LEGALLY OR IN ANY OTHER WAY. THE AREA OF LAND WHICH IS DESCRIBED AS THE "HUTT RIVER PROVINCE" IS IN FACT A PRIVATELY-OWNED WHEAT-GROWING PROPERTY NORTH OF PERTH IN WESTERN AUSTRALIA. IT HAS NO SPECIAL STATUS UNDER AUSTRALIAN LAW AND REMAINS SUBJECT TO THE AUSTRALIAN CONSTITUTION AND ALL FEDERAL AND STATE LAWS.
- 3. THE OWNERS OF THE PROPERTY SELL SOUVENIRS AND OTHER 'NOVELTY' ITEMS, SUCH AS "STAMPS" AND "LEGAL TENDER", WHICH TRADE ON THE PROPERTY'S NOTORIETY. THOSE PURPORTING TO BE OVERSEAS REPRESENTATIVES OF THE "HUTT RIVER PROVINCE" HAVE ALSO BEEN CONNECTED WITH SCHEMES TO SELL "PASSPORTS", "CITIZENSHIP", "CONSULAR APPOINTMENTS", "LEGAL TENDER" AND "ROYAL TITLES". - 4. WE CONCUR WITH POST'S ACTIONS IN BRINGING AUSTRALIA'S POSITION ON

THE "HUTT RIVER PROVINCE" TO THE ATTENTION OF LOCAL AUTHORITIES AND DIPLOMATIC MISSIONS ACCREDITED TO LEBANON. SUCH ACTIONS HAVE PROVED SUCCESSFUL IN DISPELLING CONFUSION AND CURTAILING "HUTT RIVER PROVINCE" ACTIVITIES IN OTHER COUNTRIES.

5. IN YOUR FURTHER DISCUSSIONS WITH LOCAL AUTHORITIES AND DIPLOMATIC MISSIONS, YOU SHOULD DRAW FROM THE FOLLOWING TEXT (ADMINISTRATIVE CIRCULAR P0044 OF 20 FEBRUARY 1997 REFERS):

TEXT BEGINS

THE AUSTRALIAN GOVERNMENT DOES NOT RECOGNISE THE "HUTT RIVER PROVINCE", LEGALLY OR IN ANY OTHER WAY.

THE AREA OF LAND WHICH IS DESCRIBED AS THE "HUTT RIVER PROVINCE" IS A PRIVATELY-OWNED WHEAT-GROWING PROPERTY ON THE HUTT RIVER, NORTH OF GERALDTON IN THE STATE OF WESTERN AUSTRALIA. IT HAS NO SPECIAL STATUS UNDER AUSTRALIAN LAW. IT HAS NO SEPARATE SOVEREIGNTY AND REMAINS SUBJECT TO THE AUSTRALIAN CONSTITUTION AND THE LAWS OF AUSTRALIA.

FOLLOWING FROM ITS POLICY OF NOT RECOGNISING THE "HUTT RIVER PROVINCE", THE AUSTRALIAN GOVERNMENT DOES NOT RECOGNISE THE "ROYAL TITLES" (EG. "PRINCE") NOR TITLES OF OFFICE, SUCH AS "HEAD OF STATE", "STATE MINISTER" AND "MINISTER FOR FOREIGN AFFAIRS" ASSUMED BY THE FAMILY OWNING THE PROPERTY. - \$ 47 F(1) CLAIMED HRP ''PASSPORTS'' WERE NOT FORGERIES, IN THE STRICT SENSE OF THE WORD, HOWEVER PMOC POINTED OUT THAT THEY WERE ''DECEPTIVE'' BECAUSE THEY CARRIED WORDS SUCH AS ''PASSPORT'' AND ''INDEPENDENT SOVEREIGN STATE'', ADJACENT TO ONE ANOTHER AND THAT THEY WERE BEING SOLD AS LEGITIMATE TRAVEL DOCUMENTS OF A GENUINE STATE.
- 5. IN A BIZARRE DEVELOPMENT, \$47 F(1) TABLED A COPY OF WHAT APPEARED TO BE A VERY HIGHLY CLASSIFIED, UNDATED (POSSIBLY WRITTEN IN 1989), ''DEPARTMENT OF TERRITORIES'' MINISTERIAL BRIEFING REGARDING THE HRP. THE ALLEGED BRIEFING (WHICH SHOWED SIGNS OF HAVING BEEN REMOVED FROM A LEVER ARCH FILE) INDICATED THE HRP WAS CONSIDERED A LEGAL ENTITY AND THAT ITS ''PASSPORTS'' WERE VALID. PMOC REITERATED THAT THE AUSTRALIAN GOVERNMENT DID NOT RECOGNISE THE HRP, LEGALLY OR IN ANY OTHER WAY. HOWEVER THE FACT THAT THE HRP IS EQUIPPING ITS REPRESENTATIVES WITH SUCH AN INSTRUMENT IS OF REAL CONCERN AND POSSIBLY CONTRAVENES THE OFFICIAL SECRETS ACT.
- 6. LEBANESE AUTHORITIES APPEAR BEMUSED BY THE FACT THAT THE HRP APPEARS STILL TO BE TOLERATED BY THE AUSTRALIAN AUTHORITIES. SOME OFFICIALS HAVE TOLD PMOC ITS CONTINUED EXISTENCE IS BEING INTERPRETED IN SOME QUARTERS AS DE FACTO RECOGNITION.
- 7. AT THE CONCLUSION OF THE INTERVIEW, \$  $47 \, F(1)$  UNDERTOOK TO WRITE TO ALL HRP ''PASSPORT'' GRANTEES AND ADVISE THEM THAT THE AUSTRALIAN GOVERNMENT RECOGNISES NEITHER THE HRP NOR ITS CITIZENSHIP OR TRAVEL DOCUMENTS. WE HAVE BEEN PROMISED A COPY. HOWEVER, WE FULLY EXPECT LOCAL AUTHORITIES TO PURSUE \$  $47 \, F(1)$  ACTIVITIES WITH A VIEW TO PROSCRIBING HIS HRP ROLE IN LEBANON.

WE HAVE BECOME AWARE OF A NEW SCAM INVOLVING 'HUTT RIVER PROVINCE PASSPORTS' AND THE FRAUDULENT PROFFERING OF AUSTRALIAN VISA SERVICES IN BEIRUT. THE DOCUMENTS ARE BEING USED TO OBTAIN VISAS AND AIRLINE TICKETS TO DESTINATIONS THAT REQUIRE TRANSITS THROUGH WESTERN CITIES. PMOC IS LIAISING WITH LEBANESE AUTHORITIES REGARDING SPECIFIC ALLEGATIONS AND PROVIDING ADVICE TO EMBASSIES RECEIVING THE DOCUMENTS IN CONNECTION WITH TRAVEL PLANS. MAJOR CARRIERS HAVE ALSO BEEN NOTIFIED.

- 2. THE AMBASSADOR HAS ALSO BEEN GIVEN INFORMATION ABOUT ''HUTT RIVER PROVINCE'' DOCUMENTS FOR SALE IN THE ORDER OF USD8,000. THE ALLEGATIONS ARE BEING INVESTIGATED.
- 3. IT IS ALLEGED THE VENDORS OF THESE SERVICES ALSO OFFER TO PROCURE AUSTRALIAN TRANSIT VISAS FOR TRAVEL TO THE ''HUTT RIVER PROVINCE''. ONE INFORMATION SOURCE INDICATED HE WAS TOLD THE ''AGENT'' IN DORA, A LEBANESE SUBURB, WOULD MAKE ARRANGEMENTS WITH IMMIGRATION AUTHORITIES IN WESTERN AUSTRALIA WHO WOULD, IN TURN, FACILITATE A MEETING WITH THE AMBASSADOR IN BEIRUT TO FINALISE VISA ISSUANCE, THE ENTIRE PROCESS TAKING NO LONGER THAN

45 DAYS. THE HOLDERS CLAIMED THEY HAD NOT PREVIOUSLY APPLIED FOR AUSTRALIAN VISAS, INDEED THEY HAD BEEN ACTIVELY DISCOURAGED FROM APPROACHING THE EMBASSY. (A COUPLE HAVE DONE SO, THIS WEEK, AND HAVE BEEN GIVEN CORRECTIVE ADVICE.) IT WOULD APPEAR THE ''AGENT'' HAS COPIES OF AUSTRALIAN VISITOR VISA APPLICATIONS AND IS AWARE OF SUPPLEMENTARY DOCUMENTATION THE EMBASSY REQUIRES IN SUPPORT OF VISA APPLICATIONS. GIVEN THE HIGH VISA APPLICATION RATE AT THE POST THIS IS NOT SURPRISING.

- 4. PMOC MET WITH RELEVANT OFFICIALS IN THE MFA TODAY AND OUTLINED THE HISTORY OF THE ''HUTT RIVER PROVINCE''. THE OFFICIALS CONCERNED WERE VAGUELY AWARE OF THE SCAM, HAVING RECEIVED INFORMATION A COUPLE OF DAYS AGO AND DECIDED TO APPROACH THE EMBASSY FOR ADVICE. s 33(a)(iii)
- PMOC ADVISED INTERLOCUTORS THAT DOCUMENTS PURPORTING TO BE ''PASSPORTS'' ISSUED BY THE ''HUTT RIVER PROVINCE'' ARE NOT RECOGNISED AS VALID TRAVEL DOCUMENTS BY THE AUSTRALIAN GOVERNMENT AND THAT ANY TRAVELLER SEEKING TO ENTER AUSTRALIA ON THE BASIS OF A ''HUTT RIVER PROVINCE'' DOCUMENT WOULD BE REFUSED IMMIGRATION CLEARANCE AND REMOVED FROM AUSTRALIA.
- 5. PMOC WILL CONTINUE TO LIAISE WITH THE MFA, LEBANESE POLICE AND IMMIGRATION AUTHORITIES AND OTHER INTERESTED PARTIES REGARDING NEW INFORMATION THAT COMES TO LIGHT. IN THE MEANTIME, A NOTE HAS BEEN SENT TO THE MFA AND DETAILS PROVIDED TO ALL DIPLOMATIC MISSIONS AND INTERNATIONAL ORGANISATIONS ACCREDITED IN LEBANON, AS WELL AS MAJOR CARRIERS. THE ISSUE WILL BE HIGHLIGHTED IN ANTI-FRAUD MEETINGS AND COMPLIANCE TRAINING.

#### COMMENT

- 6. THIS SCAM IS SIMILAR TO OTHERS PREVIOUSLY INVESTIGATED BY PMOC, INVOLVING (USUALLY POOR) UNEDUCATED ASPIRANTS TO PERMANENT RESIDENCE IN AUSTRALIA BEING ATTRACTED BY PROMISES OF QUICK AND EASY VISAS FOR WHICH THEY MIGHT NOT OTHERWISE QUALIFY.
- 7. IN A SEPARATE (BUT NOT DISSIMILAR) CASE RECENTLY, A LEBANESE SOURCE PROVIDED INFORMATION ABOUT AN ORGANISER WHO HAD PROMISED TO OBTAIN THREE VISAS TO AUSTRALIA, FOR USD5,700 EACH. AFTER A JOINT DIMA/AFP INTERVIEW AND FOLLOWING A BRIEFING TO THE JUDICIARY POLICE BY THE AFPLO SEARCH WARRANTS WERE EXECUTED ON TWO PREMISES IN TRIPOLI THAT RESULTED IN THE SEIZURE OF THREE PASSPORTS AND THE ARRESTS OF TWO ORGANISERS. AMONGST DOCUMENTS SEIZED WAS A PHOTOCOPY OF A LEGITIMATE AUSTRALIAN VISA. NO COPYING FACILITIES WERE INCLUDED IN THE SEIZED ASSETS. THE MATTER WAS REFERRED TO THE JOINT PEOPLE SMUGGLING TEAM IN AUSTRALIA AS THE BROTHER OF ONE OF THE DETAINEES (THE VISA HOLDER) IS AN AUSTRALIAN RESIDENT. THERE IS NO EVIDENCE THE SCAM (WHICH IS STILL BE INVESTIGATED BY POLICE) HAD ANY HIGHER PURPOSE THAN SECURING PAYMENT OF LARGE FEES BY NAIVE PASSPORT HOLDERS WHO KNEW THE ORGANISERS WERE ACTING ILLEGALLY BUT BELIEVED THEY COULD DELIVER RESULTS.
