WE WERE APPROACHED BY s 47 F(1) THE SELF STYLED
'HONORARY CONSUL-GENERAL OF THE HUTT RIVER PROVINCE' (SEE REFTTEL PARA
3) ON 18 MARCH.

2. s 47 F(1) MAIN CONCERN WAS THAT LETTERS, INCLUDING REGISTERED
MAIL POSTED FROM THE NETHERLANDS, LUXEMBOURG AND BELGIUM, WERE BEING
RETURNED TO SENDER. GENERAL MAIL WAS RETURNED WITHOUT EXPLANATION OR
ON THE GROUNDS OF INSUFFICIENT POSTAGE (EVEN THOUGH IT WAS THE
CORRECT POSTAGE FOR AUSTRALIA). REGISTERED MAIL WAS CONSISTENTLY
'DISAPPEARING' WITH ONE LETTER EVEN TURNING UP IN MELBOURNE. A
RECENT 'TEST' REGISTERED LETTER HE SENT HAS GONE MISSING WITHOUT
EXPLANATION.

3. ALTHOUGH UNABLE TO PRODUCE ANY OF THE LETTERS WHICH WERE
RETURNED, s 47 F(1) ASSURED US THAT HE HAD RECEIVED OVER 54
COMPLAINTS - ALL OF WHICH HAD OCCURRED SINCE THE ARTICLE IN THE DUTCH
NEWSPAPER 'DE TELEGRAF' WAS WRITTEN (SEE REFTTEL). WE ENQUIRED
WHETHER HE WAS IMPLYING THAT THERE WAS A CONNECTION BETWEEN THE
ARTICLE AND PROBLEMS WITH POSTAGE, TO WHICH HE REPLIED HE WAS 100%
CERTAIN THIS WAS THE CASE.

4. s 47 F(1) CLAIMED THAT A TREATY BETWEEN AUSTRALIA AND THE
NETHERLANDS DEALING WITH POSTAL RELATIONS REQUIRES THAT LETTERS MUST
BE DELIVERED AND HE IS GOING TO LODGE AN OFFICIAL COMPLAINT WITH THE
DUTCH POSTAL AUTHORITIES THAT REGISTERED MAIL IS DISAPPEARING. WE
REPLIED THAT PRESUMABLY AS AN ORDINARY DUTCH CITIZEN HE WAS ENTITLED
TO MAKE SUCH A COMPLAINT BUT THAT SIMPLY ADDRESSING LETTERS 'HUTT
RIVER PROVINCE, WESTERN AUSTRALIA' WAS NOT NECESSARILY SUFFICIENT TO
ENSURE DELIVERY. WE POINTED OUT THAT THERE WAS NO POSTCODE FOR THE
HUTT RIVER AREA AND SUGGESTED PERHAPS OBTAINING A POSTBOX IN PERTH
WOULD SOLVE THE PROBLEM.

5. WE MADE CLEAR TO s 47 F(1) THAT WE WERE ADDRESSING HIS COMPLAINT
AS WE WOULD WITH ANY ORDINARY DUTCH CITIZEN. WE ENQUIRED ABOUT HIS
CONNECTION WITH THE 'HUTT RIVER PROVINCE' WHICH SEEMS TO ESSENTIALLY
BE PROVIDING TWO WAY INVESTMENT INFORMATION FOR BUSINESS. HE
APPARENTLY ALSO HAS A FAMILY COMPANY IN VENEZUELA. HE CLAIMS TO WORK
FOR THE DUTCH MINISTRY OF ECONOMIC AFFAIRS, ALTHOUGH HIS NAME DOES
NOT APPEAR IN THE OFFICIAL DIRECTORY.

6. FOLLOWING OUR APPROACH TO MFA CONCERNING s 47 F(1) OPERATIONS
AS 'CONSUL-GENERAL', THEY CAN ONLY TAKE ACTION IF s 47 F(1) ATTEMPTS
TO FULFIL CONSULAR FUNCTIONS SUCH AS ISSUING VISAS. A COPY OF THE
THIRD PERSON NOTE FROM THE MINISTRY IS BEING FORWARDED UNDER MEMO.

7. GRATEFUL ADVICE ON THE QUESTION OF RETURNING MAIL AND ALLEGED
DISAPPEARANCE OF REGISTERED MAIL ITEMS. YOU SHOULD BE AWARE THAT

s 47 F(1) HAS GOOD CONNECTIONS WITH THE JOURNALIST WHO WROTE THE ORIGINAL ARTICLE IN 'DE TELEGRAF' AND WE CAN PROBABLY EXPECT MORE ARTICLES ON THIS ISSUE. A TIMELY REPLY WOULD BE APPRECIATED.

START OF SUMMARY

THE DUTCH NEWSPAPER 'DE TELEGRAAF' HAS RUN A STORY ABOUT THE 'HUTT RIVER PROVINCE' DESCRIBING IT AS A TAX FREE HAVEN WITH ITS OWN VALID MONEY, PASSPORTS, VISAS AND STAMPS. WE HAVE RECEIVED ENQUIRIES RANGING FROM TOURISM AND STAMPS TO TAX FREE INVESTMENT PROSPECTS.

END OF SUMMARY

WE HAVE RECEIVED ABOUT TEN TELEPHONE ENQUIRIES RELATED TO A FULL PAGE COLOUR FEATURE ARTICLE IN THE DUTCH NEWSPAPER 'DE TELEGRAAF' ABOUT THE 'HUTT RIVER PROVINCE'. AMONG THE INEVITABLE QUESTIONS ABOUT STAMPS AND TOURISM, ONE PERSON WANTED TO INVEST LARGE SUMS OF MONEY IN THE PROVINCE AS HE WAS CONVINCED IT WAS A TAX HAVEN. ANOTHER ENQUIRER WAS SEEKING A BANK THAT WOULD EXCHANGE HIS HUTT RIVER PROVINCE MONEY INTO DUTCH GUILDERS.

2. THE ARTICLE CONTAINS SEVERAL MISLEADING COMMENTS INCLUDING:
(EMBASSY TRANSLATION)

'LEONARD CASLEY GOVERNS NOW AS PRINCE LEONARD OVER HIS FULLY LEGAL HUTT RIVER PRINCEDOM, THAT IS ATTRACTING MASSIVE NUMBERS OF TOURISTS AS A TAX FREE PARADISE'

AFTER DESCRIBING HOW HE WANTED TO GIVE HIS STATE ITS OWN IDENTITY: 'IN ORDER TO DO THIS THE STATE PROVIDES A FULLY LEGAL PASSPORT. WHOEVER WISHES TO CAN OBTAIN HUTT RIVER NATIONALITY FOR 50 DOLLARS. VISITORS TO THE PRINCEDOM MUST ALSO HAVE A VISA WHICH CAN BE EASILY BOUGHT FOR THE SYMBOLLIC PRICE OF A DOLLAR. THE PRINCE ALSO HAS HIS OWN MONEY: A PERFECT REPLICIA OF THE AUSTRALIAN DOLLAR AND 24 CARAT GOLD COINS THAT ARE WORTH \$100 EACH. THE PRINCE ALSO HAS HIS OWN POSTAGE STAMPS.'

'WHOEVER THINKS IT IS NOT SERIOUS SHOULD REALISE THAT ALL OVER THE WORLD THE PRINCE IS RECOGNISED AS A FULLY LEGAL REIGNING MONARCH. HE IS RECOGNISED AS A LEGAL HEAD OF STATE FROM INDIA TO EGYPT.'

'THE PRINCE HAS MONUMENTAL PROJECTS PLANNED. AFTER ALL, HIS PRINCEDOM IS A TAX FREE PARADISE, A TAX FREE ENCLAVE IN AUSTRALIA WITH POTENTIAL INTEREST FOR TRADE AND INVESTMENT. JAPAN, WHERE THE PRINCE IS HELD IN HIGH REGARD, SEEMS TO BE MOST INTERESTED IN THE BUSINESS POSSIBILITIES OF HUTT RIVER.' (THE ARTICLE GOES ON TO DESCRIBE TOURIST POTENTIAL).

. THE ARTICLE ALSO PROVIDES A PHOTO OF MR CASLEY'S PASSPORT DESCRIBED AS 'THE OFFICIAL DIPLOMATIC PASSPORT WHICH PRINCE LEONARD USES FOR FOREIGN STATE VISITS'.

3. IT HAS ALSO BEEN DRAWN TO OUR ATTENTION THAT THE HAGUE TELEPHONE BOOK LISTS s 47 F(1) AS THE 'HONORARY CONSUL-GENERAL OF THE PRINCIPALITY OF THE HUTT RIVER PROVINCE'. WE WILL BE APPROACHING MFA CONCERNING THIS ALLEGED STATUS.

4. WE ARE ADVISING CALLERS THAT HUTT RIVER IS NOT A SEPARATE COUNTRY OR PRINCEDOM, THAT ITS MONEY, PASSPORTS, VISAS AND STAMPS ARE NOT VALID AND ARE NOT ACCEPTED ELSEWHERE AND THAT ALL AUSTRALIAN LAWS, INCLUDING TAX LAWS, APPLY TO THE REGION.

5. YOU MAY WISH TO REPEAT THIS TO OTHER POSTS AND DFAT PERTH AS REQUIRED.

6. GRATEFUL ANY ADVICE OR INSTRUCTIONS YOU MAY WISH TO PROVIDE.

THIS MAY SEEM HARD TO BELIEVE BUT WHEN SIR s 47 F(1) AND OTHER PERSONS ASSOCIATED WITH THE HUTT RIVER PROVINCE INITIALLY CAME TO THE PHIL, THEY HOSTED A FUNCTION THAT WAS ATTENDED BY MEMBERS OF THE PHIL DEPT OF FOREIGN AFFAIRS AND OTHER INFLUENTIAL FILIPINOS TO PROMOTE THE ESTABLISHMENT OF AN EMBASSY FOR THE HUTT RIVER PROVINCE IN THE PHIL. SINCE THAT TIME, DIPLOMATIC AND ORDINARY PASSPORTS FM THE HUTT RIVER PROVINCE HAD BEEN SOLD TO NUMEROUS FILIPINOS AND PERSONS OF OTHER NATIONALITIES IN THE PHIL. THE AUSTT EMB MN DID TAKE POSITIVE ACTION TO ALERT THE AUTHORITIES THAT THE HUTT RIVER PROVINCE WAS NOT RECOGNIZED BY THE AUST GOVERNMENT.

WE HAVE HAD FURTHER DISCUSSIONS WITH STATE DEPARTMENT ABOUT THEIR REQUEST FOR A DIPLOMATIC NOTE FROM THE EMBASSY TO BE USED IN DEFENDING A DAMAGES CLAIM ARISING FROM THE SEIZURE OF THE ESPERANCE IN 1984.

2. WE HAVE NOW SEEN A COPY OF THE INITIATING COMPLAINT WHICH WAS ISSUED ON BEHALF OF 6 INDIVIDUALS, 4 OF WHOM ARE DESCRIBED AS CITIZENS OF THE 'REPUBLIC OF AUSTRALIA'. THE COMPLAINT ALLEGES THAT AT THE RELEVANT TIME THE 'ESPERANCE', DESCRIBED AS A TRADITIONAL GAFF-RIGGED SAILING CLIPPER OF 100 FOOT LENGTH, WAS REGISTERED IN THE HUTT RIVER PROVINCE 'WITH THE KNOWLEDGE AND ASSISTANCE OF THE GOVERNMENT OF WESTERN AUSTRALIA'. THE HUTT RIVER PROVINCE IS STATED TO BE 'AN INDEPENDENT SOVEREIGN STATE WITHIN AUSTRALIA', WHICH 'HAS BEEN ACCORDED INTERNATIONAL RECOGNITION BY SEVERAL SOVEREIGN STATES AND MEMBERS OF THE UNITED NATIONS'.

3. THE CLAIM IS BASED IN PART ON ALLEGED MISCONDUCT CAUSED BY THE FAILURE OF THE DEPARTMENT OF STATE TO INFORM THE COAST GUARD AND THE DRUG ENFORCEMENT AGENCY THAT THE ESPERANCE WAS NOT STATELESS. s 33 (a)(iii)

WE HAVE BEEN APPROACHED BY THE STATE DEPARTMENT (OFFICE OF INTERNATIONAL CLAIMS, LEGAL ADVISER'S OFFICE) WITH A REQUEST THAT THE EMBASSY PROVIDE A DIPLOMATIC NOTE CONFIRMING THAT CERTAIN ADVICE WAS GIVEN ORALLY BY THE EMBASSY (COUNSELLOR (LEGAL)) TO THE STATE DEPARTMENT IN JUNE 1984 CONCERNING THE NON-REGISTRATION AS AN AUSTRALIAN VESSEL OF 'ESPERANCE', A 65 FOOT KETCH. THE NOTE IS SOUGHT FOR USE BY THE U.S. GOVERNMENT IN DEFENDING A CIVIL CLAIM BROUGHT BY THE OWNERS OF THE 'ESPERANCE' FOR ALLEGED UNLAWFUL SEIZURE, SEARCH AND DETENTION.

2. EMBASSY FILES INDICATE THAT QUESTION WAS RAISED WITH CANBERRA ON 18 JUNE 1984 WITH REPLY ON SAME DATE TO EFFECT THAT 'ESPERANCE' WAS NOT ON AUSTRALIAN REGISTER. (MESSAGES O.WH49023 AND O.CH203047.) THAT INFORMATION WAS APPARENTLY PASSED TO U.S. AUTHORITIES WHO PROCEEDED WITH ARREST ON THE HIGH SEAS, SEARCH AND DETENTION. SUBSEQUENT PAPERS ON FILE SUGGEST THAT 4 AUSTRALIANS WERE INVOLVED AND THAT VESSEL MIGHT INDEED HAVE BEEN AUSTRALIAN-OWNED, ALBEIT UNREGISTERED. IT SEEMS POSSIBLE THAT ALTHOUGH FLYING THE AUSTRALIAN FLAG THE VESSEL CLAIMED 'HUTT RIVER' REGISTRATION, BUT IT DOES NOT SEEM THAT THE 'HUTT RIVER' ANGLE WAS RAISED AT THE TIME OF THE EXCHANGE OF MESSAGES ON 4 JUNE 1984.

3. WE UNDERSTAND THAT THE PAPERS FILED IN SUPPORT OF THE CLAIM (OF WHICH WE HAVE ASKED FOR A COPY) ASSERT THAT 'ESPERANCE' HAD AUSTRALIAN NATIONALITY AT THE RELEVANT TIME.

4. WE ARE INCLINED TO MEET THE STATE DEPARTMENT REQUEST AND FURNISH A NOTE CONFIRMING THAT THE AMERICANS WERE TOLD IN JUNE 1984 THAT THE VESSEL WAS NOT AUSTRALIAN-REGISTERED. HOWEVER, THE RECORD IS A LITTLE UNSATISFACTORY AS IT IS NOT CLEAR WHETHER WE MEANT TO CONVEY -

(A) THAT THE VESSEL'S CLAIM TO AUSTRALIAN NATIONALITY WAS UNFOUNDED BECAUSE OF THE ABSENCE OF REGISTRATION, AND, SO FAR AS AUSTRALIA WAS CONCERNED, THE U.S. COULD TREAT IT AS STATELESS: OR

(B) THAT WHETHER OR NOT THE VESSEL VALIDLY CLAIMED AUSTRALIAN NATIONALITY (WHICH COULD NOT BE ASCERTAINED IN ABSENCE OF REGISTRATION), AUSTRALIA, EVEN IF THE FLAG STATE, HAD NO OBJECTION TO THE SEARCH AND ARREST.

5. BEFORE REPLYING WE SHALL SEEK MORE INFORMATION ON WHAT THE CLAIMANTS NOW ASSERT AS TO THE STATUS OF THE VESSEL AT TIME OF SEIZURE. IN THE MEANTIME, WE WOULD BE GRATEFUL FOR ADVICE WHETHER YOU SEE ANY OBJECTION TO OUR SENDING THE REQUESTED NOTE. ALSO, WHILE THE DISTINCTION BETWEEN (A) AND (B) ABOVE MIGHT NOT BE IMPORTANT IN THE LITIGATION, WE WOULD BE GRATEFUL FOR ANY COMMENT ON IT.

BEGINS...

''HUTT RIVER PROVINCE PRINCIPALITY''

IN RESPONSE TO A NUMBER OF ENQUIRIES, THE AUSTRALIAN EMBASSY HAS FELT IT DESIRABLE TO CLARIFY THE AUSTRALIAN GOVERNMENT'S VIEW WITH REGARD TO THE SO-CALLED ''HUTT RIVER PROVINCE PRINCIPALITY''. THE ACTIVITIES OF THE ''PRINCIPALITY'' AND ITS PURPORTED REPRESENTATIVES IN MANILA HAVE RECENTLY BEEN THE SUBJECT OF A NUMBER OF NEWSPAPER REPORTS.

THE AUSTRALIAN GOVERNMENT'S VIEW, WHICH HAS BEEN SETTLED FOR MANY YEARS, IS THAT IT DOES NOT RECOGNISE THE ''HUTT RIVER PROVINCE''. ANY ASSERTIONS TO THE CONTRARY ARE FALSE. THE ''PROVINCE'' IS MERELY A PRIVATE PROPERTY LOCATED ON THE AUSTRALIAN MAINLAND.

THE SELF PROCLAIMED ''PRINCE LEONARD OF HUTT RIVER PROVINCE'' CONTINUES, HOWEVER, BY VARIOUS MEANS, TO SEEK RECOGNITION ABROAD FOR THE INDEPENDENCE OF HIS ''PRINCIPALITY''. HIS LATEST UNSUCCESSFUL ATTEMPT WAS IN MANILA WHERE HIS ''FOREIGN MINISTER'' AND ''AMBASSADOR'' CALLED ON THE PHILIPPINES DFA IN AN ATTEMPT TO HAVE AN ''EMBASSY'' ACCREDITED IN THE PHILIPPINES.

- HE SAW A SPECIAL ASSISTANT TO THE FOREIGN MINISTER, AMBASSADOR s 33 (a)(iii) ON 26 MAY.

MR LEONARD CASLEY AND THE 'HUTT RIVER PROVINCE'

35. WE HAVE RECENTLY RECEIVED REQUESTS FOR CLARIFICATION FROM DIPLOMATIC MISSIONS IN CANBERRA CONCERNING THE STATUS OF MR LEONARD CASLEY AND THE 'HUTT RIVER PROVINCE'.

36. MR CASLEY HAS MASQUERADED UNDER THE NAME 'PRINCE LEONARD OF HUTT' FOR MANY YEARS NOW, AND HAS BUILT HIS WHEAT-GROWING PROPERTY IN WESTERN AUSTRALIA INTO A THRIVING TOURIST ATTRACTION. SUCCESSIVE AUSTRALIAN GOVERNMENTS HAVE ASCHEWED ACCORDING CASLEY ANY OF THE STATUS HE HAS SOUGHT. HE PAYS AUSTRALIAN TAXES AND HIS ACTIVITIES GENERALLY REMAIN WITHIN THE LIMITS PERMITTED BY AUSTRALIAN LAW.

37. MR CASLEY IS, HOWEVER, INCREASING HIS ACTIVITIES OVERSEAS AND AMONG MISSIONS IN CANBERRA. IN HONG KONG HE HAS APPLIED FOR A TRADE MARK IN THE NAME OF 'THE EMBASSY OF THE HUTT RIVER PROVINCE LIMITED'. IN CANBERRA HE RECENTLY SENT A NOTE TO THE UNITED STATES EMBASSY PROTESTING AT THE APPREHENSION IN THE UNITED STATES OF A SHIP PURPORTING TO HAVE BEEN REGISTERED IN THE 'PROVINCE'.

38. THE THEN MINISTER FOR FOREIGN AFFAIRS SUMMARISED AUSTRALIAN POLICY ON THE ISSUE IN A STATEMENT TO PARLIAMENT ON 27 MAY 1982 IN THE FOLLOWING TERMS:

'IN 1976, MY DEPARTMENT ADVISED ALL OVERSEAS POSTS THAT ANY INQUIRIES FROM GOVERNMENTS REGARDING THE ACTIVITIES OF MR CASLEY SHOULD BE ADVISED THAT THE AUSTRALIAN GOVERNMENT DOES NOT RECOGNISE THE HUTT RIVER PROVINCE AND ANY ASSERTIONS TO THE CONTRARY ARE FALSE. THE AUSTRALIAN GOVERNMENT WILL TAKE WHATEVER STEPS ARE NECESSARY TO PROTECT ITS INTERNATIONAL STATUS'.... (SENATE HANSARD, 27.5.82, P.2605).

39. THIS REMAINS THE GOVERNMENT'S POSITION. WE ARE PARTICULARLY CONCERNED THAT OVERSEAS AUTHORITIES BE DISCOURAGED FROM DOING ANYTHING THAT MIGHT LEAD MR CASLEY TO BELIEVE HIS INTERNATIONAL REPUTATION OR STATUS OR THAT OF HIS FARM ARE GATHERING MOMENTUM.
