PART1

- A decision granting access to a document but not granting, in accordance with a request under the Act, access to all documents to which the request relates.
- 3. A decision under the Act to defer the provision of access to a document.
- 4. Any other decision under Part III of the Act in relation to an application for access to documents.
- 5. A decision under section 29 of the Act relating to imposition of a charge or the amount of a charge.
- 6. A decision relating to exempt documents under Part IV of the Act.
- 7. A decision to grant access to a document only to a qualified person under subsection 47F(5) of the Act.
- 8. A decision in relation to the amendment or annotation of a record of personal information in accordance with an application made under section 48 of the Act.

PART 2

- 1. A decision referred to in Part 1 of this Schedule.
- 2. Under section 54C of the Act, on the application of a person in accordance with section 54B of the Act, review a decision referred to in section 54 or 54A of the Act (other than a decision made by the responsible Minister or the principal officer of the agency) and make a fresh decision in respect of the matter reviewed.
