s 22	To delete exempt or irrelevant material from a document
s 25(2)	To issue a notice
s 26A	To consult with a State
s 27	To consult with a person, organisation or proprietor of an undertaking
s 27A	To consult with a person or the person's legal representative
s 29	To impose a charge
s 29	To extend the time for payment of a charge
s 29(4)	To reduce a charge or not to impose a charge
s 47F(5)	To direct that access to documents be given instead to a qualified person
s 50	To grant or refuse a request to amend a personal record
s 51B	To annotate a personal record
s 51C	To transfer a request
s 54B	To allow a further period for making an application for internal review
s 54C	To review an original decision to grant or refuse access to a document and make a fresh decision
