1 Name of Instrument

This instrument is the *Chief Executive Officer's Freedom of Information Act 1982 Authorisation Instrument 2011 (No.1 [ATSB 11/2011])*.

2 Commencement

This instrument commences when it is signed.

3 Definitions

In this instrument:

APS 5 Legal means the designated APS 5 position in Legal Services of the ATSB.

CEO means the Chief Executive Officer referred to in section 15 of the TSI Act.

Note in accordance with section 15(2) the Chief Commissioner is the CEO.

Classification Rules means the rules issued under section 23 of the *Public Service Act 1999*.

EL 2 means an APS employee who is classified as an Executive Level 2 employee under the above Classification Rules.

EL 2 Legal means the person occupying the position of an Executive Level 2 position in Legal Services of the ATSB.

GM (EL 2) means the designated General Manager position, Aviation Safety Investigations, in the ATSB's Organisation Chart.

Manager (EL 2) Legal means the designated Manager, Legal position in the ATSB's Organisation Chart.

SES 1 means an SES employee who is classified as a Senior Executive Service Band 1 employee under the above Classification Rules.

Note Section 17AA and subsection 46(1) of the *Acts Interpretation Act 1901* incorporate the definition of SES employee from the *Public Service Act 1999*.

the Act means the *Freedom of Information Act 1982*.

the ATSB means the Australian Transport Safety Bureau established by section 12 of the TSI Act. It includes the staff of the ATSB in accordance with section 16 of the TSI Act.

TSI Act means the *Transport Safety Investigation Act 2003*.

4 Authorisation

- (1) Each of the persons for the time being occupying or performing the duties of the following positions:

- SES 1
- GM (EL 2)

to exercise all of my powers and functions under the Act.

- (2) The persons for the time being occupying or performing the duties of the position of:

- Manager (EL 2) Legal
- EL 2 Legal
- APS 5 Legal

to exercise my powers and functions under section 29 of the Act.

5 References to branch or section

Unless the contrary intention appears, a reference to a branch or section is a reference to such organisational structure within the ATSB.

6 Revocations

- (1) This instrument revokes the *Chief Executive Officer's Freedom of Information Act 1982 Authorisation Instrument 2010 (No.3 [ATSB 27/2010])*.
