I would also like to express my dismay at the difficulty of getting access to what is public data in a reasonable manner such that it can be used for the public good. If the AGD had the technical ability to not break the search mechanism in the first place, we would not be in the position we are in now.

- I would like to vary Part A of my request:
- (a) A machine-parseable dump (ie SQL dump) of the entire Classification database.

I would like to ask what you consider an appropriate scope for Part B to be such that it would not be an unreasonable diversion of your resources.

If possible, I would also like to append the following parts to my request:

- (c) All documents, quotes and emails pertaining to the determination of scope and cost relating to Part A and Part B of this freedom of information request;
- (d) Documents pertaining to the process used by freedom of information request personnel at AGD for:
  - (i) defining scope of a request
  - (ii) quantifying cost of completing a request
- (e) Answers to the following questions:

- (i) In relation to the 209,909 records specified in the previous email, how did the AGD do a record count if there is no on-site IT personnel capable of creating a dump of the database when doing a query to count records in a database is one step away from recording the output in a file?
  - (ii) Which contractors were consulted regarding the \$4000 quote?
