Freedom of Information - Access Decision Letter Request No. 170106

I refer to your request of 8 January 2017 to the Department of the Environment and Energy (the **Department**), in which you have sought access under the *Freedom of Information Act 1982* (Cth) (the **FOI Act**) to:

A digital copy of all written submissions received by the department in response the EPBC Act referral for Reef Management Pty Ltd/Water Management/Green Island/QLD/Green Island Desalination Plant - Ref#2001/331.

Authority

I am authorised by the Secretary of the Department under section 23 of the FOI Act to make a decision in relation to this request.

Background

On 18 January 2017 you agreed that the scope be limited to only seek formal submissions, that is, those made in response to an invitation by the Department regarding the EPBC Act referral for Reef Management Pty Ltd/Water Management/Green Island/QLD/Green Island Desalination Plant - Ref#2001/331.

Decision

After considering your FOI request and conducting thorough searches of Departmental records, I have decided not to grant access to the requested documents pursuant to section 24A(1)(b)(ii) of the FOI Act, as I am satisfied they do not exist (our records show that no public submissions were received in respect of EPBC 2001/331).

Material considered in making decision

In making my decision I have considered:

- the FOI request;
- the FOI Act:

- advice from subject matter experts within the Department; and
- the Guidelines issued by the Australian Information Commissioner under s93A of the Freedom of Information Act 1982 (the **FOI Guidelines**).

Reasons for Decision

Section 24A(1)(b)(ii) Requests may be refused if documents cannot be found

Subsection 24A(1)(b)(ii) of the FOI Act provides that a request for access may be refused if all reasonable steps have been taken to find the document, and the agency is satisfied that the document does not exist.

The Department conducted the following searches to locate the documents sought:

- relevant hardcopy departmental files;
- · electronic folders;
- · relevant databases; and
- shared group and personal drives.

As a result of these searches, no documents were found to fall within the scope of your request. This is not a surprising outcome, as our records show that no public submissions were received in respect of EPBC 2001/331.

For the reasons above, I am satisfied that the requested documents do not exist and I have decided not to grant access to the documents subject to your request pursuant to section 24A(1)(b)(ii) of the FOI Act.
