RE: YOUR FREEDOM OF INFORMATION REQUEST

I refer to your email of 26 February 2017 (<u>Attachment A</u>) in which you sought access to the following information under the *Freedom of Information Act 1982* (FOI Act):

"all documents wherein the outcome of any enterprise bargaining ballots were communicated to the department by the entity who undertook the ballots. This shall include the YES/NO vote amounts or percentages as well as any additional information related to the vote. For example, a breakdown of the vote by employee location, or APS level. The scope of this request covers any such documents that were received as a result of EBA offers made to staff under: Workplace Bargaining Policy 2015 or Australian Government Public Sector Workplace Bargaining Policy 2014"

Response to your request

I am an authorised decision maker under section 23 of the FOI Act.

The ABS has conducted an exhaustive search for documents relating to your request. I am now able to notify you that eight documents exist pertaining to your request. I have decided to give you access to all eight documents in part. The documents being released to you are at <u>Attachment B</u>.

Statement of reasons

Redactions have been made to the documents for the following reasons:

I have decided that three documents contain information which is exempt under section 47 of the FOI Act as they disclose trade secrets or commercially valuable information of third parties which would reasonably be expected to be diminished if disclosed.

I have decided that all eight documents contain information which is exempt under section 47F of the FOI Act. Section 47F provides for documents 'which would involve the unreasonable disclosure of personal information about any person' to be exempt. These documents contain information about the names and contact details of ABS staff or employees of third parties, which after consideration of the facts I have determined it would be unreasonable to disclose.

As section 47F is a conditional exemption; I have determined that the release of this information would be contrary to the public interest as it would have an adverse impact on the ability of the ABS to fulfil its legislated functions. Therefore access will not be granted.

Charges

There is no charge for this request.

Internal Review of the Decision

Section 54 of the FOI Act gives you the right to apply for an internal review of the decision by the ABS. Additionally, you may request a review of this decision by the Information Commissioner. Details of both procedures involved in an application to review a decision are set out at Attachment C.

1. APPLICATION FOR INTERNAL REVIEW OF DECISION

2. APPLICATION TO AUSTRALIAN INFORMATION COMMISSIONER (INFORMATION COMMISSIONER) FOR REVIEW OF DECISION






