### **Acknowledgement of your request for Internal Review**

I refer to your request for internal review in relation to the decision by the Department of Human Services (the **department**) dated 27 July 2017 on your request for access to documents under the *Freedom of Information Act 1982* (the **FOI Act**).

The reference for your original request is LEX 28338. The reference for this internal review is LEX 31128.

### **Decision on internal review**

Your request for an internal review of LEX 28338 was received by the department on 31 July 2017 and the 30 day statutory period for processing your request commenced from the day after that date. You should therefore expect a decision from us by 30 August 2017.

In accordance with section 54C of the FOI Act, a person (other than the person who made the original decision) will be the decision maker for this internal review.

### **Disclosure Log**

Section 11C of the FOI Act requires this publication, however it is subject to certain exceptions, including where publication of personal, business, professional or commercial information would be unreasonable.

### **Exclusion of junior staff details**

The department is working towards ensuring that all staff have a choice about whether they provide their full name, personal logon identifiers and direct contact details in response to public enquiries. Where such details are included in the scope of a request, this may add to processing time and applicable charges as it may be necessary to consider whether the details are exempt under the FOI Act. On this basis, unless you tell us otherwise, we will assume that these details are out of scope of your request and they will be redacted under section 22 of the FOI Act.
