FOI Application – July 2013 Rollout Statistics

I am writing in relation to your request made under the *Freedom of Information Act 1982* (**the FOI Act**). In particular, you sought NBN Co's rollout and activation figures for the period 31 July 2013.

As outlined in my FOI decision of 5 September 2013, NBN Co deferred access to the July 2013 rollout statistics for approximately 60 days and pending review of that information by the company's board and executive. As the deferral period has ended, I am providing you with the information requested, which is found at **Attachment 1**.

In accordance with the FOI Act, NBN Co is required to publish documents provided to FOI applicants within 10 working days after release. The information you seek may be published in full (as released to you) or with some additional redactions as per section 11C of the FOI Act. - Figures are rounded to the nearest '00. For reference, NBN Co's reporting cycles do not always correspond to the end of a given month. After undertaking the relevant searches required by the FOI Act, I was satisfied that as per section 24(b)(ii) no such documents existed. However, I have endeavoured to provide the most relevant data and to the closest proximate date requested, being 4 August 2013 for the July 2013 rollout data.
- NBN Co does not report this metric, but is calculated as "Construction commenced or completed less premises passed".
- At the requested date there were 184,800 premises passed, all of which will be able to order a service. 124,200 were able to order a service via an RSP at the requested date. The majority of the remaining premises are MDUs (multiple dwelling units) which will be able to be connected in accordance with NBN Co's MDU processes.
- (4) NBN Co does not report this metric, but is calculated as "Construction commenced or completed less premises covered".
