Re: Freedom of Information (FOI) Request

I refer to your e-mail of 22 August 2017 in which you seek access under the provisions of the *Freedom of Information Act 1982* ('the FOI Act') to:

"Please provide an itemised summary of all trips booked with your travel provider for 2016-2017 in a spreadsheet format".

This revised your earlier request of 14 August 2017 for access to:

"Can you please provide the travel expenses, invoices, receipts, credit card statements and reimbursements for the most expensive trip taken by a Minister or Assistant Minister in your Department's portfolio area in 2016-17."

As such, we interpret your email of 22 August as relating to trips taken by the Department's Ministers and Assistant Ministers.

I am authorised under section 23 of the FOI Act to make decisions, and have been appointed to be the decision-maker on your request in line with departmental procedures.

I advise that a search of files undertaken by relevant line areas has failed to identify any document relevant to the scope of your request. As advised in our email to you of 18 August 2017, you may view the latest expenditure reports for the period of 1 July 2016 to 31 December 2016 on the Department of Finance's website at:
