Freedom of Information Request No. 201700026

I refer to your request under the Freedom of Information Act 1982 received on 8 August 2017. I have taken your request to be for access to:

Documents related to the ten most recent instances where an employee has sought information, advice, guidance, or opinion on their social media use in a private capacity and where the scope of documents is limited to:

- o the original request from the employee
- o the University's response
- o any follow-up questions and response
- o where the original request was created in the last 2 years.

The relevant area of the University was contacted and a search conducted of their records for documents relating to instances where University staff have sought information, advice, guidance, or opinion on their social media use in a private capacity, but no relevant paper based or electronic documents could be located.

I am required to give you a decision on your request and as no document relating to your request exists. I have decided, as an officer authorised under section 23(1) of the FOI Act to make decisions in relation to FOI requests, to refuse your Freedom of Information request under section 24A(1).

Given that no relevant records were located concerning your request, no processing charge has been applied.

I refer you to the University's Guideline: Social media participation by ANU staff which applies to The Australian National University's community members who contribute to social media.
