Freedon of Information Request

On 8 August 2017 TT-Line Company Pty Ltd (**TT-Line**) received an email from you titled "Right to Information request - Private use of social media advice provided to employees".

The email was generated using righttoknow.org.au and states that it is a request made "under the Freedom of Information Act".

TT-Line is based in Tasmania. In Tasmania, the freedom of information legislation is called the *Right to Information Act* 2009 (**RTI Act**).

Under the RTI Act, a person is entitled to lodge an application for assessed disclosure with TT-Line. I take the view that your email of 8 August 2017 was an attempt to make an application of this nature.

Under the RTI Act, TT-Line is only obliged to accept and respond to valid applications for assessed disclosure. The requirements of a valid application are outlined in Division 2 of Part 1 of the RTI Act.

Amongst other things, in order to be valid an application for assessed disclosure must be accompanied by an application fee of 25 fee units (currently \$38.75) or a request that this fee be waived on the basis that the applicant is:

- (a) impecunious; or
- (b) a Member of Parliament acting in connection with his or her official duty; or
- (c) able to show that he or she intends to use the information for a purpose that is of general public interest or benefit.

Any request to waive the fee must be supported by evidence.

Putting to one side all of the other requirements of a valid application, your application does not include the fee or a request that the fee be waived. On that basis, your application will not be processed at this time.

For your information I **attach** TT-Line's standard form for making applications for assessed disclosure and note that TT-Lines Right to Information Policy is available on our website.
