Hi Amanda,

Thanks for your email regarding the disclosure log.

For background, most of the FOI requests CASA receives are for personal information (medical records, licensing information) or documentation regarding individual operators.

It is very rare that the information released to FOI applicants is of a general nature and therefore appropriate to be placed on CASA's disclosure log.

Regarding the removal of previous FOI documents from the site, I think the documents from 2014 and 2015 can be removed.

I agree with your comments regarding the link going to a PDF document – the link goes to a previous decision. Suggest we keep the text "Information attached to, or referred to, in CASA's disclosure log will generally be removed after 12 months, unless the information has enduring public value." but remove the link. Documents can be viewed by clicking on the specific matter in the table anyhow.

I note your comments regarding the table not being optimized for mobile. I think we can hide those columns as long as they are still viewable if the user wishes to see them. Part 14.34 of the OAIC Guidelines says agencies should publish "whether the FOI applicant was given access to all documents that were requested, and if not, the exemption or other basis on which partial access was granted".



Just wanted to touch base about this page: https://www.casa.gov.au/foi/standard-page/disclosure-log

The text says that it's a legislative requirement to publish FOI disclosures but the page hasn't been updated for nearly 12 months. Our text also says: "Information attached to, or referred to, in CASA's <u>disclosure log</u> will generally be removed after 12 months, unless the information has enduring public value."

Just wondering if the information on this page (and the FOIs in the log) need to remain and if there is any new content from the last 12 months that should be added?

I also note that the PDF linked in this par (the words 'disclosure log') goes to what appears to be a particular disclosure, which I don't think is an accurate link?

Also the table isn't optimised for mobile. We can either shrink the table, or in this case I would suggest for mobile that we 'hide' two columns – the reference number and the exemption. Are you comfortable with this approach?
