Description: On the 14th November 2011 at approximately 2032 hours Client Service Officer (CSO) Kerry Crossingham (not on Portal) notified Operational Manager (OM) Arif Djumadi that s. 47F(1) s. 47F(1) climbed on to s. 47F(1) Compound roof to gain access to s. 47F(1) Compound as he was denied inter ? compound visits to s. 47F(1) Compound. s. 47F(1) was advised by Client Service Manager (CSM) Raju Dhamodaran stated that approved was needed for him to be able to visit s. 47F(1) compound. s. 47F(1) at approximately 2037 hours descended into the s. 47F(1) Compound and walked across the oval towards the s. 47F(1) began to climb the fence at approximately 2038 hours Response One Code Black was called by CSO Rahatullah Khan (not on Portal). s. 47F(1) donned socks on his hand and worn Dunlop sneakers. All response officers attended the scene. CSM Lanh Tran, CSW Joanne Parker (not on Portal), CSO Patrick Glavieux and CSO Emmanuel Mubaira went into the Sterile Zone while CSM Raju Dhamodaran, CSO Michael Skinnon(not on Portal), CSO Adrian Hyde (not on Portal), CSO Lucky Moto (not on Portal), CSO Joshua Chisholm (not on Portal), CSO Richard Allan were standing on the same side as s. 47F(1) who was on the top of the fence attempting climb over. The shocks given by energised fence deterred his movement. CSM Tran and Dhamodaran spoken to s. 47F(1) several times and he stated that he wants to visit s. 47F(1) tonight and this is how he was going to gain access. s. 47F(1) tried to disconnect the energised fence numerous times as he was trying to climb over. CSO Adrian Hyde and CSO Emmanuel Mubaira brought mattresses and placed them on other side of the fence as a precautionary tool. At approximately 2055 hours s. 47F(1) expressed to CSM Dhamodaran that he wishes to come down. CSO Mariusz Szymanski fetched a step ladder from Control room. At Approximately 2100 hours s. 47F(1) came down. He was asked to come to the Interview room in s. 47F(1) Compound, he was non compliant and continued to walk towards the s. 47F(1) and sat down. s. 47F(1) repeatedly shouted abuses at officers and instantly refused to meet the terms of officers? request. At approximately 2115 hours CSM Dhamodaran directed CSO Chisholm, CSO Hyde, CSO Mubaira, CSO Skinnon and CSO Moko to relocate s. 47F(1) using approved control and restraint technique to s. 47F(1) interview room. CSO Skinnon held s. 47F(1) right arm and CSO Chisholm held s. 47F(1) left arm and CSO Hyde assisting the client to move forward. While moving the client s. 47F(1) tried to pull s. 47F(1) away from the escorting officers. CSM Dhamodaran and CSO Glavieux pulled s. 47F(1) away from s. 47F(1) and the escorting officers walked s. 47F(1) on though to the interview room where he was offered a seat and he refused. CSW Parker offered medical assistance s. 47F(1) did not acknowledge the offer. s. 47F(1) was offered water, a seat and medically assistance at 5 minutes interval to which he refused each time. From approximately 2145 hours til 2248 hours 5x CSO Skinnon, Chisholm, Hyde, Mubaira, Moko, Glavieux and CSM Dhamodaran continued to control and restraint s. 47F(1) on a rotational basis until he appeared exhausted and dropped to the floor. He was placed in recovery position. CSW Parker called for an ambulance at approximately 2313 hours. Ambulance arrived at approximately 2328 hours. s. 47F(1) departed to Royal Darwin Hospital at approximately 2344 hours. s. 47F(1) returned to the Northern Immigration Detention Centre at approximately 0518 hours and was taken into the interview rooms and spoken to by OM Djumadi before being accommodated into s. 47F(1)
