Re: Freedom of Information Request

I refer to your current request for access under the *Freedom of Information Act 1982* (FOI Act) to:

“Documents relating to any discussion or advice (given or received) regarding the ALRC Copyright Review in the context of the Trans-Pacific Partnership Agreement”.

I am authorised under section 23 of the FOI Act to make access decisions, and have been appointed to be the decision-maker on your request as required by departmental procedures. I have been provided with the documents identified in searches within the Department as relevant to your request.

Decision

After careful consideration of the material and the terms and context of your request, I have identified 22 documents as being relevant to your request. I have decided to release 21 documents in full (with irrelevant material deleted) and to release one document in part.

Section 26 of the FOI Act provides that where access to a document has been denied in full or in part, a statement must be provided to the applicant setting out findings on material questions of fact, the material on which those findings were based, and the reasons for the decision. Please find this information below.

Material considered

The material on which my decision is based includes:

- the request and the documents within the scope of the request;
- the FOI Act;
- the Guidelines issued by the Office of the Australian Information Commissioner under section 93A of the FOI Act; and

- the views of third parties consulted.

Reasons for my decision, including any material findings of fact

Some material has been deleted under section 22(1)(a)(ii) of the FOI Act, which allows material that is either irrelevant to the request or exempt from release to be deleted, to enable the remaining material in the document to be released.

I have decided to delete material which I consider to be outside the scope of the FOI request, and therefore irrelevant to you. I have also decided to exempt the personal information (names and contact details) of junior employees of the Department. I note that where there is no need for contact with a particular public servant in the future, disclosure of the public servant's name may be unreasonable and I have therefore deleted the identifying details of junior staff.

With regard to document number 14, please note that I have also exempted the names of stakeholders and departmental officers, as I do not consider that their details are relevant to the scope of your request.

Some material is exempt from disclosure under section 33(a)(iii) of the FOI Act, which provides as follows:

"A document is an exempt document if disclosure of the document under this Act would, or could reasonably be expected to, cause damage to the international relations of the Commonwealth".

The material in question is exempt from disclosure as its release could reasonably be expected to cause damage to Australia's international relations. Release of this material would reveal confidential negotiating text between the parties to the Trans-Pacific Partnership ('TPP') agreement. In my opinion, the public disclosure of this information would adversely affect Australia's negotiating position and working relationships with other countries. Release could also reduce the willingness of representatives of foreign governments to share information with Australian officials in future. This in turn would have a substantial adverse impact on DFAT's ability to advance Australia's international interests.

Some material is exempt from release under section 33(b) of the FOI Act, which provides that:

"A document is an exempt document if disclosure of the document under this Act would divulge any information or matter communicated in confidence by or on behalf of a foreign government, an authority of a foreign government or an international organization to the Government of the Commonwealth, to an authority of the Commonwealth or to a person receiving the communication on behalf of the Commonwealth or of an authority of the Commonwealth".

I have exempted from release material that was communicated in confidence by or on behalf of a foreign government to the Australian Government. Public disclosure of the material in question could put at risk relations with foreign government contacts, could reduce the quality and/or quantity of future information provided to the Australian Government and could have a substantial adverse impact on the Department's ability to perform its functions.

Your review rights

Internal review

Under the provisions of section 54 of the FOI Act, you are entitled to request a review of my access decision. Your request in writing within 30 days of the date of this letter should be directed to:
