#### Dear DB

I refer to your request dated 9 June 2018 for access to documents under the *Freedom of Information Act 1982* (FOI Act) and the decision on your request dated 10 August 2018.

On 11 September 2018, you were informed that a third party had objected to the disclosure of documents and requested internal review of the 10 August 2018 decision.

This letter is to advise you of my decision on internal review.

# Authority to make decision

I am authorised by the Merit Protection Commissioner under section 23(1) of the FOI Act to make decisions in relation to FOI applications.

#### Decision

I have decided to vary the decision made by Ms Read on 10 August 2018 as follows:

- Affirm the decision to release in full documents, or parts of documents, in the public domain
- Affirm the decision to exempt parts of documents 7, 8, 14 and 15 containing sensitive information of a third party under s 47F
- Affirm the decision to release document 3 except for identifying information of a third party (s22)
- Vary the decision to release documents 2, 10 and 13 to exempt signatures on letters under s47F
- Vary the decision to release documents 4 to 6 (except for identifying information of a third party) to a decision to exempt content in the documents that constitutes personal information under s 47F.

## Material taken into account

I have taken the following material into account in making my decision:

- the content of the documents that fall within the scope of the FOI application
- the FOI Act (specifically sections 22 and 47F)
- the guidelines issued by the Australian Information Commissioner under section 93A of the FOI Act

The schedule enclosed with this decision indicates each document and the decision for each document as varied by this decision.

You agreed to exclude from the scope of your request the names of third parties who are not public servants or members of Parliament and I have not reconsidered Ms Read's decision in relation to those names.

My reasons for granting access are given below.

#### Reasons for decision

# Personal information

Section 47F conditionally exempts a document to the extent that its disclosure would or could involve the unreasonable disclosure of personal information about any person. Personal information has the same meaning as in the *Privacy Act 1988*, in which it is relevantly defined as information or opinion about an identified individual or an individual who is reasonably identifiable. I am satisfied that the documents contain information that says something about identifiable individuals and is personal information for the purposes of s 47F.

I have taken into account that the personal information in the documents is not well known or otherwise in the public domain.

Information in documents 7, 8, 14 and 15 about an individual is of a private, sensitive nature that is not well known or in the public domain. I find disclosure would cause that person harm and distress.

Information in documents 2, 10 and 13 contains signatures and contact details for individuals that is not well known and the disclosure of which could cause harm.

Information in documents 4, 5 and 6 concerns the nature of a complaint and FOI request made by a third party and communications with that third party. Information in the complaint and communications is not well known or in the public domain. The information is of a nature that its disclosure could cause distress or harm to an individual. I find that person would have a reasonable expectation that their personal information would not be made publically available and disclosure would be unreasonable in these circumstances.

I find the documents are conditionally exempt under s 47F.

I have considered the objects of the FOI Act including the public interest in documents of the agency being made available to the public to promote oversight of the agency's activities. However, I find the giving of access to the documents would make a negligible contribution to discussion or debate on a matter of public importance. However, the interference with the privacy of the individual(s) would be significant.

On balance, I find disclosure would be contrary to the public interest and the information is exempt under s 47F.

## Third party review rights

The third party can seek review of my decision to the Australian Information Commissioner. I cannot give you access to the documents until the review rights of a third party who objected to disclosure run out. The third party has 30 days to seek either review of my decision. I will notify you if an application for review is made.
