Re: Freedom of Information Request

I refer to your current request for access under the *Freedom of Information Act 1982* (FOI Act) to obtain documents relating to Australia's support for the Joint Statement on the Promotion and Protection of Civil Society issued by the White House on 23 September 2013.

I am authorised under section 23 of the FOI Act to make access decisions, and have been appointed to be the decision-maker on your request as required by departmental procedures. I have been provided with the documents identified in searches within the Department as relevant to your request.

Decision

After careful consideration of the material and the terms and context of your request, I have identified 4 documents as being relevant to your request. I have decided to release all documents in full (with irrelevant material deleted).

Reasons for my decision, including any material findings of fact

Some material has been deleted under section 22(1)(a)(ii) of the FOI Act, which allows material that is either irrelevant to the request or exempt from release to be deleted, to enable the remaining material in the document to be released. Some of the deleted material refers to matters which are reasonably irrelevant to your request, as they are not about the joint statement. Cable metadata, such as automatically generated distribution list has also been deleted as reasonably irrelevant to your request.

I have also decided to exempt the personal information (names and contact details) of junior employees of the Department. Where I have assessed that there is no need for contact with that particular public servant in the future, disclosure of that person's name may be unreasonable.

Notwithstanding my decision to release the documents in full, your review rights are as follows.

Internal review
