Charges Notice under Section 29 of the Freedom of Information Act 1982

I refer to your request for access to documents under the *Freedom of Information Act 1982* (the **FOI Act**), as follows:

- 'a) Documents relating to any investigations, reviews or routine checks undertaken by the ADHA (or suppliers or subcontractors of ADHA) to determine if any breaches in security have occurred for any electronic records held, maintained or overseen by the ADHA in the period 1 July 2016 to 2 November 2018 inclusive; and
- b) Documents relating to the final version of procedures currently in use as at 2 November 2018 by the ADHA which outline the methods by which the application of updates, upgrades and "patches", both routine and ad-hoc to all hardware used by the ADHA to maintain electronic health records are correctly applied and assured; and
- c) Documents relating to the final version of procedures currently in use as at 2 November 2018 by the ADHA which outline the methods by which the application of updates, upgrades and "patches", both routine and ad-hoc to all software used by the ADHA to maintain electronic health records are correctly applied and assured; and
- d) Documents relating to the final version of procedures in use as at 1 July 2016 by the ADHA which outline the methods by which the application of updates, upgrades and "patches", both routine and ad-hoc to all hardware used by the ADHA to maintain electronic health records are correctly applied and assured; and
- e) Documents relating to the final version of procedures in use as at 1 July 2016 by the ADHA which outline the methods by which the application of updates, upgrades and "patches", both routine and ad-hoc to all software used by the ADHA to maintain electronic health records are correctly applied and assured.'

I am writing to advise you of my decision that you are liable to pay a charge in respect of the processing of your request.

I, Kathryn Dolan, am an officer authorised under section 23(1) of the FOI Act to make decisions in relation to FOI requests.

In accordance with section 29 of the FOI Act and the *Freedom of Information Charges Regulations 1982*, my preliminary assessment of the charge you are liable to pay is \$8,851.85.

Basis for my preliminary assessment of the charge

I have assessed the work the Australian Digital Health Agency would need to do to process your request and have calculated a breakdown of charges, provided in detail at **Attachment A**.

Your right to contend the charge

Under the FOI Act, you have the right to contend that the charge:

- has been wrongly assessed;
- should be reduced; or
- should not be imposed.

In deciding whether a charge should be reduced or not imposed, the decision-maker in our agency must take into account:

- whether payment of the charge, or part of it, would cause you financial hardship;
- whether giving access to the documents is in the general public interest or in the interest of a substantial section of the public; and
- any other relevant matter.

Payment of a deposit

As the charge exceeds \$100, a 25 per cent deposit of \$2,212.96 is payable to progress the request.

The deposit is not refundable except in some limited circumstances, for example, if the Agency fails to make a decision on your request within the statutory time limit. The charges may be refundable in part if the final charge is less than the deposit paid.

The Agency can accept Electronic Funds Transfer (EFT, and is preferred), money order or cheque payments.

The time you have to respond and what you need to do

You have 30 days to respond in writing to this notice. We therefore expect a response from you by close of business 19 January 2019. By that date, you must do one of the following things in writing:

- agree to pay the charge (this will mean that you will not be entitled to access the requested documents until the full charge is paid);
- contend that the charge has been wrongly assessed, or should be reduced or not imposed and explain your reasons; or
- withdraw your request.

If you do not provide us with a written response by 19 January 2019, your request will be taken to have been withdrawn.

The period for processing your request is suspended from the day that you receive this notice and resumes on either the day you pay the charge (in full or the required deposit) or the day on which this agency makes a decision not to impose a charge.
