

DECISION MAKING POWERS AUTHORISED TO OFFICERS CONTAINED IN SCHEDULE A, PURSUANT TO SECTION 23(1) OF THE *FREEDOM OF INFORMATION ACT 1982*

| Relevant section or Part of FOI Act | Description of decision-making power |
|-------------------------------------|---|
| s16 | A decision to transfer an FOI request |
| s20(3) | A decision to refuse access to a document in a particular form, and to grant access to the document in another form |
| s21 | A decision to defer the provision of access to a document |
| s22 | A decision to delete exempt or irrelevant matter from a document |
| s24 | A decision to refuse a request for access to a document |
| s24A | A decision to refuse a request for access to a document |
| s26A | A decision to consult with a State |
| s27 | A decision to consult with a person, organisation or proprietor of an undertaking |
| s27A | A decision to consult with a person or that person's legal representative |
| s29(1) | A decision to impose a charge |
| s29(1) | A decision to extend the time for payment of a charge |
| s29(4) | A decision to reduce a charge or not impose a charge |
| s30 | A decision to remit or partly remit an application fee |
| Part III, Part V | A decision to grant or deny access to a document under Parts III or IV of the Act |
| s41(3) | A decision to grant access to a document only to a qualified person |


