Freedom of Information Act 1982 (Cth)

I, **Dr Michele Bruniges AM**, Secretary of the Department of Education and Training (department), make this instrument under sub-sections 10A(1) and 23(1) of the *Freedom of Information Act 1982* (Cth) (the FOI Act):

- (a) **Revoke** instrument DoEd 14-065.
- (b) **Approve** the following arrangements pursuant to subsections 10A(1) and 23(1) of the FOI Act, and hereby authorise:
 - i. under subsection 23(1) of the FOI Act – those officers who from time to time hold, occupy, or perform the duties of a position specified in Column 2 of Schedule 1 to make decisions specified in Column 3 of Schedule 1; and
 - ii. under subsection 10A(1) of the FOI Act – those officers who from time to time hold, occupy, or perform the duties of a position specified in Column 2 of Schedule 2 to exercise powers and functions under Part II (Information Publication Scheme) of the FOI Act, including, without limitation, the powers or functions referred to in Column 3 of Schedule 2.

If the name of an office, position, team, branch, or group (an entity) in the department changes and that entity continues performing the same functions and duties under the new name, then the delegations to that entity, or office or position in that entity, under this instrument continue unaffected.
