Dear Mr Gothe-Snape,

I refer to your request, dated 9 January 2019, made to the Department of the Prime Minister and Cabinet (the Department) in which you made a request under the *Freedom of Information Act 1982* (the Act), in the following terms:

'The document containing the most senior authorisation for the Prime Minister's 2018 family Christmas picture used on his website before 8 January 2019. If no explicit authorisation for the picture exists, can you provide the most senior authorisation of the website revisions containing the 2018 family Christmas picture before 8 January 2019.'

Authorised decision-maker

I am authorised to make this decision in accordance with arrangements approved by the Department's Secretary under section 23 of the Act.

In making my decision, I have considered the following:

- the terms of your FOI request;
- the provisions of the Act;
- consultations with the Department's FOI advisers; and
- Guidelines made by the Australian Information Commissioner issued under section 93A of the Act (FOI Guidelines)

Decision

Subsection 24A(1) of the Act provides that:

An agency or Minister may refuse a request for access to a document if:

- (a) all reasonable steps have been taken to find the document; and
- (b) the agency or Minister is satisfied that the document:
 - (i) is in the agency's or Minister's possession but cannot be found; or
 - (ii) does not exist.

Relevant staff in the Department were asked to conduct thorough searches for documents falling within the scope of your FOI request. No such documents were found.

For completeness, the authorities that you have requested were provided verbally. As such, no written authorisations exist.

I am therefore satisfied that all reasonable steps have been taken to find documents and that the Department holds no documents relevant to your request. Consequently, I have decided to refuse your request under section 24A(1) of the Act.

Review rights

Information about your rights of review is attached to this decision.

Complaint rights

You may make a complaint to the Information Commissioner about the Department's actions in relation to this decision. Making a complaint about the way the Department has handled an FOI request is a separate process to seeking a review of the Department's decision.
