**Freedom of Information (FOI) request - Access Decision**

On 8 February 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

**1 Scope of request**

You have requested access to the following document:

*Subclass 189 visa applications received from Jan 2018 to date, grouped by month, ANZSCO code 253111 (General Practitioners) - originally from the UK.*

- 1) *Total number of applications received, granted, refused; and*
- 2) *Processing times for 189 applications.*
