#### Freedom of Information Request No. FOI 027-2019

I refer to your request for access to documents made under the *Freedom of Information Act 1982* (**FOI Act**) dated 18 February 2019 by which you requested access to documents in the possession of the Australian Securities and Investments Commission (**ASIC**).

Your request sought access to:

'The Treasurer, the Hon Josh Frydenberg MP has written to the Chairman of ASIC, James Shipton, following the release of the Final Report of the Hayne Royal Commission on 1 February 2019.

The document or documents I seek are <u>copies of such letters as well</u> <u>as any correspondence from James Shipton to the Treasurer.</u>

The search period is <u>1 February 2019 to the present</u>.' (my emphasis added)

- 2. You may within 60 days after the day on which you have been notified of this decision, apply in writing to the Office of the Australian Information Commissioner (OAIC) for a review of my decision under section 54N of the FOI Act. You may contact the OAIC by post at GPO Box 5218 Sydney NSW 2001, by email at enquiries@oaic.gov.au or by telephone on 1300 363 992.

#### Right to complain

3. You may lodge a complaint with the OAIC in relation to the conduct of ASIC in the handling of this request. You may contact the OAIC as described above.
