# Re: Freedom of Information (FOI) Request

I refer to your e-mail of 23 February in which you seek access under the provisions of the *Freedom of Information Act 1982* (FOI Act) to:

documents (including, but not limited to, emails, letters or other notes to which the department has access) which reference requests, decisions or opinions by the current minister of the Department on how the department should handle Freedom of Information (FOI) requests.

I am authorised under section 23 of the FOI Act to make decisions, and have been appointed to be the decision-maker on your request in line with departmental procedures.

I have to advise that a thorough search of the Department's file records has failed to identify any document relevant to the scope of your request. As you are aware, the Department and the Minister's Office are separate entities under the FOI Act. While the Department provides practical assistance to the Minister's Office in processing FOI requests which it receives (OAIC Guideline 2.22 refers), the Department neither seeks nor receives guidance from the Minister regarding the processing of requests received by the Department.

I therefore am unable to meet your request in accordance with the provisions of section 24A(1)(b)(ii) as DFAT holds no documents relevant to your request.

#### Internal review
