**Freedom of Information (FOI) request - Access Decision**

On 13 March 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*How many refugee and humanitarian entrants who have been resettled in Australia through the offshore Refugee and Humanitarian Program have been proposed by a person in Australia, for example, through the use of the proposal form 681.*

*Please provide a breakdown by financial year and by visa subclass, for the financial years 2015/16 to 2017/18, as well as up to 13 March 2019.*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
