Freedom of information request: Reference 19-057

I refer to your application made under the *Freedom of Information Act 2016* (the Act), received by Transport Canberra and City Services Directorate (TCCS) on 19 June 2019, in which you sought access to documents containing the following information:

- 1. For the period 1 Jan 30 Mar 2019, the daily passenger numbers for all buses that ran from Gungahlin to Canberra City (eg. 200, 251, 252, 255, 57, 58) and the daily passenger numbers for all buses that ran from Canberra City to Gungahlin.
- 2. For the period 20 Apr 19 Jun 2019, the daily passengers numbers for the light rail vehicles both ways ie. from Gungahlin to Canberra City and from Canberra City to Gungahlin.

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

TCCS was required to provide a decision on your access application by 22 July 2019. Thank you for the extension until 26 July 2019.

Decision on access

This information is held in a data base. Two documents have been created from the database which contain the information that you have requested.

I have decided to release the information in full to you.

Charges

As the number of documents is below the fee charging threshold of 50 documents there are no charges.

Online publishing – disclosure log

Under section 28 of the Act, TCCS maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents will be

published in the TCCS disclosure log from 3 days after the date of this decision. Your personal details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision under section 73 of the Act within 20 working days from the day that my decision is published in TCCS' disclosure log, or a longer period allowed by the Ombudsman.
