A small number of demonstrators with placards and handing out pamphlets for a group calling themselves Victims of Financial Fraud have assembled outside 100 Market St and for while they were blocking access to 100 Market St.

A copy of the pamphlet they were handing out is attached.

ASIC's security team are working with Westfield security (who were very quick to act) have moved the protestors off the Westfield property line and removed any hindrance to Westfield and ASIC staff accessing the building.

There hasn't been any violence that I am aware of and I expect the media will arrive soon if they are not already here. We have done all we can for now, we will monitor the situation and Westfiled Security seem to have the situation under control.
