Dear Mr Stewart

I refer to your request of FOI 1374 to the Department of Health (department) seeking access under the *Freedom of Information Act 1982* (Cth) (FOI Act) to the following documents:
'all working papers, information, data, submissions, emails from NQPHN in relation to Call My Doctor Pty.'

Notice of Third Party Consultation

It appears, from the documents to which you seek access, that a third party may reasonably wish to make a contention concerning possible exemption of some of the documents. Accordingly, Ms Kristin English, Director, FOI & Legislation Support Section, an officer authorised under section 23(1) of the FOI Act to make decisions in relation to freedom of information requests, has determined the requirements of sections 27 and 27A of the FOI Act make it appropriate to extend the time frame for dealing with your request.

Pursuant to section 15(6) of the FOI Act, the period for providing you with a decision has been extended by a further period of 30 days. This means the department must, not later than 60 calendar days after the day on which your request was received, take all reasonable steps to notify you of a decision on your request.

The period of 60 calendar days is, however, suspended by virtue of the Notice of Liability to Pay a Charge below.

Notice of Liability to Pay a Charge

Ms English has decided you are liable to pay a charge in respect of the processing of your request.

Preliminary Assessment

In accordance with section 29 of the FOI Act and the *Freedom of Information (Charges) Regulations 2019*, my preliminary assessment of the charge you are liable to pay is \$98.75.

This has been calculated as follows:

search and retrieval time (including time spent locating relevant files and collating relevant documents contained on those files)	2.1 hours @ \$15.00 per hour	\$31.50
decision making time (including time spent examining the documents, considering exemptions, undertaking consultation, writing the decision and preparing any documents for release)	8.3625 hours @ \$20.00 per hour	\$167.25
	Less first 5 hours free	(\$100.00)
TOTAL		\$98.75

Deposit

Ms English has also decided you are required to pay a deposit of \$20.00. Payment of a

deposit is taken as your authority to proceed with processing of your request and your agreement to pay the full charge in which case you will become liable to the Commonwealth for the full cost of processing the charge.

Response

Under the FOI Act, you have 30 days to respond in writing to this notice. You must, within 30 days after this notice is given, do one of the following things: (i) agree with the department's estimate and pay the deposit or whole charge if no deposit is listed, or (ii) advise the department in writing you contend the charge has been wrongly assessed, or should be reduced or not imposed, giving reasons for your contention, or (iii) advise the department in writing you withdraw the request for access to the documents concerned. Please send your response to the above postal address or [this email address](#). If you do not provide a response within 30 days, your freedom of information request will be taken to have been withdrawn.

If you choose to make a contention the charge should be reduced or not imposed, the department must, in making a decision on your contention, take into account the matters set out in section 29(5) of the FOI Act or any relevant matter.

Processing time

Processing of your request and counting the 60 calendar days are suspended from the date you receive this notice and resume either when you pay the deposit or when any contention you make about the charge has been resolved.
