### Your Freedom of Information Request

I refer to your email of 3 April 2014 to the Australian Curriculum, Assessment and Reporting Authority (ACARA) seeking access to documents under the *Freedom of Information Act 1982* (Commonwealth) (FOI Act). I also refer to our subsequent correspondence.

#### 1. Your request

I note that you seek access to the following:

“how NAPLAN score for subjects were equivalized for 2010, 2011, 2012 and 2013”.

#### 2. My comments

I understand that Peter Matheson has already advised you that:

- The NAPLAN score equivalency tables for 2010, 2011 and 2012 have previously been released under Freedom of Information, and are noted in ACARA's FOI disclosure log: ([http://www.acara.edu.au/acara\\_freedom\\_of\\_information\\_disclosure\\_log.html](http://www.acara.edu.au/acara_freedom_of_information_disclosure_log.html)). I have treated this part of your request as an FOI disclosure log request. Peter Matheson has recently provided you with these documents by email.
- The NAPLAN score equivalency tables for 2013 have not been previously released under Freedom of Information.

### 3. My decision

I have identified one (1) document relevant to your request. I have decided to release this document in full. I set out at **Attachment 1** details relating to this document and enclose a copy of this document.

### 4. Decision On Charges

The *Freedom of Information (Fees and Charges) Regulations (Regulations)* prescribes the charges that can be levied in respect of a request for access to a document or the provision of access to a document. These charges are set out in the Regulations and are for search and retrieval of documents, decision making and provision of access (for example, copying and postage).

Sub-regulation 3(1) of the Regulations provides an agency with a discretion as to whether it will impose any charge. In relation to this request, I have decided **not** to impose a charge.
