Freedom of Information (FOI) Request No. 19/20-073

- I refer to your correspondence received by Services Australia on 21 November 2019, in which you
 requested access under the Freedom of Information Act 1982 (the FOI Act) to:
 - "1. The annual number of DSP recipients from 1992.
 - 2. The annual number of DSP recipients for each state and territory from 1992. Totals for all eight States and Territories will reconcile with the figures in point 1.
 - 3. The annual number of NSA recipients who have a disability from 1992.
 - 4. The annual number of NSA recipients who have a disability for each state and territory from 1992. Totals for all eight States and Territories will reconcile with the figures in point 3."
- 2. On 27 November 2019, Services Australia advised you that the request would be transferred to the Department of Social Services (the department).
- 3. On 28 November 2019, the department advised you by email of the following:
 - ... duplicate documents and non-Senior Executive Service (SES) employees names, contact details and signatures, as well as mobile phone numbers and signatures of SES employees, will be excluded from the scope of your request under s22(1)(b)(ii) of the FOI Act.
- 4. I have decided that there is no charge for processing your request.
- I am an authorised decision maker under subsection 23(1) of the FOI Act and my decision regarding your request and the reasons for my decision are set out below.

Decision on access

Items 1 and 2

- 6. Data relating to the Disability Support Pension is publicly available from a variety of sources as outlined below:

- For the period June 1994 to June 2001, data can be accessed from library publications 'Income Support Customers: A Statistical Overview'; and
- For the period June 1992 to June 1993, data can be sourced from the department of Social Security Annual Reports.
- 7. The data has been compiled and is attached to this decision.

Items 3 and 4

8. In accordance with section 17 of the FOI Act, the department produced a report from its database that satisfies the terms of the request. I have decided to release the extracted document to you in full. Please note: Partial Capacity to Work for recipients of Newstart Allowance who have a physical, intellectual or psychiatric impairment and an assessed work capacity of less than 30 hours per week was introduced in 2006, therefore data prior to this date is not available.

Your rights of review

Internal Review

Section 54 of the *Freedom of Information Act 1982* (FOI Act) gives you the right to apply for an internal review of this decision. The review will be conducted by a different person to the person who made the original decision.
